**THE CITY OF BRADFORD METROPOLITAN DISTRICT COUNCIL PUBLIC SPACE PROTECTION (CITY PARK DOGS ON LEADS ) EXTENSION ORDER No2/ 2020 relating to extension of the Dogs on leads (City of Bradford Metropolitan District Council) Order 2011.**

This extension Order is made by the City of Bradford Metropolitan District Council ("the Council") under section 60 of the Anti-Social Behaviour, Crime and Policing Act 2014 (the Act)

1. This extension Order relates to the public places described in the Dogs on Leads (City of Bradford Metropolitan District Council) Order 2011.
2. The Council is satisfied on reasonable grounds that to extend the 2011 order is necessary to prevent—
  - (a) occurrence or recurrence after that time of the activities identified in the order, or
  - (b) an increase in the frequency or seriousness of those activities after that time.
3. The effect of this Order is to impose the prohibitions as set out in the 2011 order from 00.01hours 21<sup>st</sup> October 2020 namely that within the described areas a person or persons are prohibited from the activities set out in the attached 2011 order.
4. Any person who fails without reasonable excuse to comply with the requirements imposed on him/her by this Order or does anything that s/he is prohibited from doing by this Order commits an offence and is liable on summary conviction to a fine not exceeding level 3 on the standard scale or may be issued with a fixed penalty notice requiring payment of a sum not exceeding £100.
5. This Order will remain in force until midnight on 20<sup>th</sup> October 2023 or until the coming into force of the 2021 City of Bradford Metropolitan District Council Composite Public Space Protection order (Dog Control) at which time it will be discharged.

**The Dogs on Leads (City of Bradford Metropolitan District Council)**  
**Order 2011**

The City of Bradford Metropolitan District Council hereby makes the following Order:

1. This Order comes in force on Monday 6<sup>th</sup> February 2012
2. This Order applies to the land specified in the Schedule.

**Offence**

3. (1) A person in charge of a dog shall be guilty of an offence if, at anytime on any land to which this Order applies he does not keep the dog on a lead, unless –
  - (a) he has a reasonable excuse for failing to do so; or
  - (b) the owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his failing to do so.
- (2) For the purposes of this article a person who habitually has a dog in his possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog.

**Penalty**

4. A person who is guilty of an offence under article 3 shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.

## SCHEDULE

[Specification/description of land, or lands, to which the Order applies]

1. This order applies to all the land which is in the administrative area of the City of Bradford Metropolitan District Council described below and shown edged red on the plan attached hereto:
  - (i) which is open to the air (which includes any land which is covered if it is open to the air on at least one side) and
  - (ii) to which the public are entitled or permitted to have access (with or without payment).
2. All highways, footpath, footways and adjacent grass verges maintained at public expense.
3. Description of Land:
  - (i) All the land within the City Park, Bradford, West Yorkshire, bounded by Princes Way, Bridge Street and Hall Ings as edged in red on the plan below save as indicated in (ii) below.
  - (ii) The Mirror Pool in the City Park and the Fountain in Norfolk Gardens, City Park, as edged in blue on the plan below, are excluded from this Order. The Mirror Pool and the Fountain are the subject of the Dogs Exclusion (City of Bradford Metropolitan District Council) Order, 2011, excluding any dog from the Mirror Pool and the Fountain.
