Business Rates 2024-25

What are Business Rates?

Business Rates is a tax set by national government but is collected by local authorities.

Pay your bill on time

You must pay your Business Rates by the date shown on the front of your bill. If you cannot pay on time, you must contact us immediately with an alternative payment proposal.

Keep your information up to date

It is your responsibility to tell us about changes which may affect your Business Rate bill. You should tell us about any changes within 21 days. We may request evidence, such as leases, to support any changes you tell us about.

What happens if I don't pay?

If you don't pay your bill on time, the council will take action to enforce payment. This will include;

- Issuing a summons to court,
- Enforcement Agents calling to recover monies due including taking your personal or business assets/ goods in settlement of the sums outstanding,
- Personal bankruptcy or the liquidation of your company.
