	<p><u>Licensing Service Response</u></p> <p>Drivers are encouraged to book vehicle tests at least 4 weeks in advance of expiry. This is to ensure efficiency of service. It is common for drivers whose vehicle safety inspections are due to expire to book the later slots or drivers that are not concerned about receiving their plates on the same day.</p> <p><u>Appointment time for Badges</u></p> <p>It takes approximately 17 minutes to be issued with a badge from start to finish which is below the 20 minute timeslots that have been allocated by Licensing Service. Drivers on average wait 10 minutes before they are seen. The whole process can take between 20 and 30 minutes depending on the complexity of the case.</p>
