WASTE MANAGEMENT DEVELOPMENT PLAN DOCUMENT (DPD) EXAMINATION

I am writing to you to as an individual or representative of an organisation making representation(s) on the City of Bradford MDC Waste Management DPD.

The Inspector who is undertaking the examination of the Waste Management DPD, Mr Stephen J Pratt, BA (Hons) MRTPI, has now carried out his initial examination of the submitted Waste Management DPD, including consideration of the representations made. He has now published the document 'Guidance Note and Schedule of Matters, Issues & Questions for Examination', (document number PS/A004) relating to the Waste Management DPD. I am pleased to attach this document, which sets out the main Matters, issues & Questions on which the Inspector is seeking additional information.

The Schedule of Matters, Issues & Questions for Examination (MIQs) is published in order to seek further information about the legal compliance and soundness of the Plan. He has invited the Council to submit responses to the MIQs, in statements no longer than 3000 words per Matter. Anyone who has made a representation on the published Waste Management DPD may submit further statements, if necessary, responding to specific matters and issues relevant to their original representation, with a similar limit of 3000 words per Matter, with no supplementary appendices or additional material. Any further statements should be submitted to reach me by 4.00pm on Friday 16 September 2016. Please note that the Examination process does not provide the opportunity to make further submissions/representations to the Plan nor raise new issues and evidence not related to your original representation to the Council on the DPD.

At this stage, and since no representor has sought an oral hearing, the Inspector is not considering holding any hearing sessions to discuss issues relating to the soundness of the Plan. However, he will review the position when he has received any further responses from the Council and representors to the MIQs.

Since the publication of the submitted Waste Management DPD, the Council has added some additional documents to the Examination library, including a list of proposed modifications, which are available by clicking on the appropriate link on the Examination web-page under the section 'Documents from the Council' PS/B001-6; further documents will be added as they are issued. Documents from the Inspector and Programme Officer are listed at PS/A001-5.

If you have any queries about the process regarding submission of a written statement to the MIQs, or how to establish how your representation to the Waste Management DPD is recorded, please do not hesitate to contact me. At present I am working part-time on the Examination but aim to respond to all emails within two working days.
