## FOREWORD

---

This document sets out how Bradford Council will seek to engage the public in considering the *Core Strategy – Further Engagement Draft* which sets out the proposed strategy and policies to guide development within the Bradford District until 2028. It sets out the aims and principles that will underpin the public consultation on the Core Strategy Development Plan Document (DPD) and will be referred to as the Engagement Plan.

The Local Development Framework will form a portfolio of Local Development Documents (LDDs) that will guide future growth and development in the Bradford District in the period up to 2028. The District faces some major challenges ahead arising from development pressure for new housing, retail and commercial premises and the supporting infrastructure, services and facilities required to facilitate major growth and regeneration.

The Core Strategy will set out the long-term spatial vision for the District and strategic policies to deliver that vision. The Core Strategy will then inform all the other Development Plan Documents to be produced as part of the LDF.

One of the key aims of the Planning system is to strengthen community involvement in the planning of the places in which people live and work. Importance is placed on community involvement throughout the preparation of the Development Plan Documents, in particular at the early stages. Local Planning Authorities are required to prepare a Statement of Community Involvement (SCI) which sets out how the Council intends to engage with the community in preparing its LDF and also how it engages with the community in dealing with planning applications. Bradford Council is committed to ensuring that everyone has an equal opportunity to play an active and positive role in considering the planning issues, which affect them and the District. The SCI for Bradford was adopted by Full Council on 8<sup>th</sup> July 2007.

The Council undertook a range of engagement in developing the proposed approach set out in the Further Engagement Draft, in particular two rounds of informal public consultation at the Issues and Options stage to identify the key issues for Bradford and the possible options for future development. This public consultation on the Further Engagement Draft forms the next consultation stage in developing the Core Strategy. It provides a further opportunity for the community to consider the big issues facing the District, help shape the long-term vision and ultimately the strategic policies and proposals to deliver the vision.

This Engagement Plan has been developed based upon:

- Town and Country Planning (Local Development) (England) (Amendment) Regulations 2008; and 2009 Revision
- Planning Policy Statement (PPS) 12: Local Spatial Planning (2008)

- Planning Advisory Service (PAS) – Plan Making Manual
- CBMDC Statement of Community Involvement (SCI) (2008)
- CBMDC Local Development Scheme (LDS) (2007)

This Engagement Plan is separated into three parts:

- **Part One** sets out the aims and principles that will underpin the public consultation on the proposed approach for guiding development in the Bradford District until 2028, as set out in the Core Strategy Further Engagement Draft.
- **Part Two** forms a consultation and participation plan which sets out how the Council will meet the aims and principles in Part 1 and comply with the adopted Statement of Community Involvement (SCI).
- **Part Three** sets out how the consultation and engagement will be recorded and how any comments received will be taken into consideration during the next stage of developing the Core Strategy DPD.

## PART ONE: AIMS AND PRINCIPLES

---

### 1.0 Background - What is a Local Development Framework (LDF)?

- 1.1 The current development plan for Bradford, the Replacement Unitary Development Plan (RUDP), was formally adopted by the Council on 15<sup>th</sup> October 2005. Following the introduction of the Planning and Compulsory Purchase Act in 2004, the RUDP policies were 'saved' for a period of 3 years from their adoption. On 30<sup>th</sup> September 2008, the Secretary of State issued a Direction and Schedule of Saved Policies which would remain in place until the LDF is formally adopted. A total of 16 RUDP policies were deleted by the Secretary of State.
- 1.2 The Planning and Compulsory Purchase Act (2004) introduced planning reform intended to speed up the British planning system. This led to the change from the current style of development plans, *land use* planning, to *spatial* planning. The land use planning system consisted of a single use plan known as a Unitary Development Plan (UDP) covering a District. Local Authorities are required to produce a Local Development Framework which is made up of a series of separate documents known as Local Development Documents (LDDs).

### Local Development Documents (LDD)

- 1.3 Documents that make up the Local Development Framework are called Local Development Documents; these have to have regard and conform to the policies and guidance put forward by Government in Planning Policy Statements (PPS) and Planning Policy Guidance (PPGs), along with policies in the Regional Spatial Strategy (RSS). There are two compulsory types of Local Development Documents; these include Development Plan Documents (DPD's) and the Statement of Community Involvement (SCI).

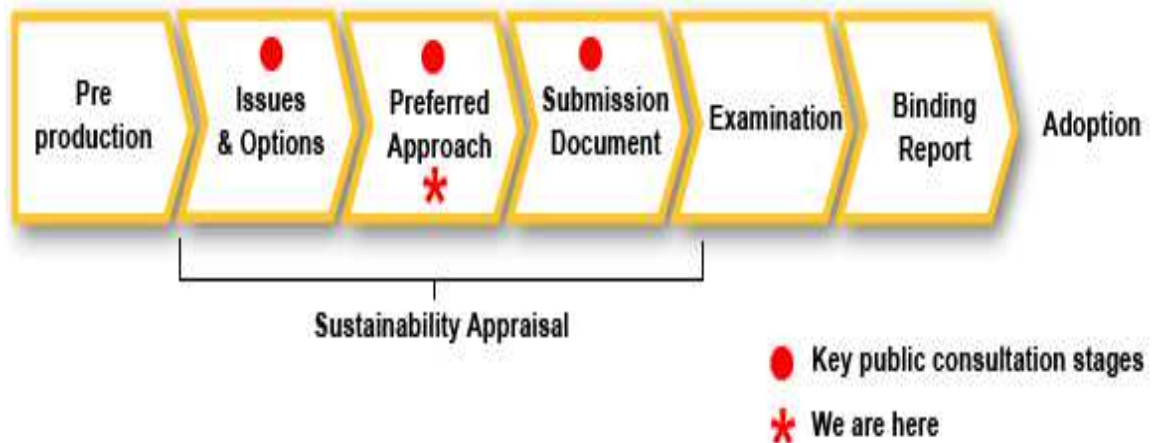
### Development Plan Documents (DPD)

- 1.4 These are documents that form part of the statutory development plan for the District and are subject of a Public Examination by an independent Inspector. These include the following:

DEVELOPMENT PLAN DOCUMENT (DPD)	DOCUMENT DESCRIPTION
<b>Core Strategy DPD</b>	This document sets out the spatial vision for the District, the strategic policies for guiding development, the housing requirement, and a framework for monitoring and implementing the Strategy.

<b>Waste Management DPD</b>	This document sets out the spatial strategy and policies for dealing with waste streams within the district. It will also identify waste management sites for dealing with different stream of waste.
<b>Allocations DPD</b>	This document identifies sites for development including housing, Jobs as well as green space.
<b>Area Action Plans DPD</b>	These documents set out a planning framework that is targeted at a specific area of change or conservation.
<b>Proposals Map DPD</b>	This document will show the proposals for the District on an OS Map base, and will be updated as individual documents are adopted.

- 1.5 The revision of Planning Policy Statement 12: Local Spatial Planning and associated planning regulations in 2008 dissolved the need for Local Authorities to undertake consultation at both the Issues and Options and the Preferred Options stage, instead these have been merged to form one round of early public consultation. As consultation on the Issues and Options had already taken place within Bradford, the decision was made to progress the Core Strategy in line with the superseded regulations to allow for a further consultation stage - Further Engagement Draft - before the formal submission stage. The Core Strategy DPD will go through the following stages as part of its preparation:



- 1.6 All DPDs will be tested thoroughly at an independent public examination to see whether they satisfy the statutory requirements for the preparation of a plan and determine if it is 'sound'. PPS12 sets out the criteria for assessing whether a DPD is 'sound'. To be sound the Development Plan Document must be justified, effective and consistent with national policy<sup>1</sup>. One legal requirement of the plan is whether the DPD has been prepared in compliance with the adopted Statement of Community Involvement (SCI).

#### **Statement of Community Involvement (SCI)**

- 1.7 The Statement of Community Involvement sets out how the Council intends to engage the community in producing Local Development Documents that make up the Local Development Framework, and in the consideration of planning applications. The SCI is itself a Local Development Document that is the subject of a Public Examination by an independent Inspector.
- 1.8 Bradford's SCI was adopted on 8<sup>th</sup> July 2007. All other Local Development Document's will have to comply with the requirements for community involvement as set out within the adopted SCI.
- 1.9 This Engagement Plan will set out how the Further Engagement Draft consultation will be in accordance with the adopted SCI through an identification of who will be consulted, by what means and when this will happen. Following this consultation, a Statement of Consultation will record exactly what took place and the outcomes of all the meetings, events and comments.

#### **What is a Core Strategy?**

- 1.10 Planning Policy Statement (PPS) 12: Local Spatial Planning provides guidance on the content of a Core Strategy. It should normally be the first Development Plan Document (DPD) to be produced, and once adopted all other Local Development Documents (LDDs) must conform to it. In the case of Bradford, the Waste Management DPD is being produced concurrently with the Core Strategy. However, the examination in public of these documents will take place sequentially so that the principle of conformity of the other DPDs to the Core Strategy can be tested.
- 1.11 The Core Strategy will set out the key elements of the planning framework for the Bradford District over the next 15-20 years. In particular it will set out the long term spatial vision for the District and the strategic policies required in delivering that vision. It should look at least fifteen years from the anticipated adoption date, and

beyond where the Regional Spatial Strategy (RSS) sets a longer term time horizon.

The Core Strategy will include:

- A Spatial Vision
- Strategic Objectives;
- Spatial Strategy;
- Core Policies; and
- A clear, achievable monitoring and implementation framework.

1.12 Insofar as the DPDs are concerned it must take into account the need to contribute appropriately to national, regional and local requirements at acceptable social, environmental and economic costs. It should be in general conformity with the RSS for the Yorkshire and the Humber, until it is formally revoked. The Core Strategy is a key component in delivering the District's Sustainable Community Strategy (SCS) – The Big Plan (2008), and the longer term Vision 2020. It should also seek to support the spatial delivery of other relevant local strategies such as the Local Transport Plan (LTP).

1.13 In light of revisions to planning policy, Councils now have the opportunity to tailor the process of plan preparation to their needs and local context, in accordance with the Regulations. The Planning Advisory Service (PAS) provides an online *'Plan Making Manual'* to accompany the revised PPS12 which provides guidance, advice and best practice on the preparation, content and delivery of Core Strategies.

1.14 The main thrust of the guidance within the Plan Making Manual maintains the principals of previous guidance publications. The main points are that a Core Strategy should:

1. Contain a clear spatial vision, strategic objectives and a delivery strategy to achieve the objectives;
2. Be supported by what physical, social and green infrastructure is needed to support any development within the area;
3. Be guided by sustainability principles and practices;
4. Avoid repeating or reformulating national and regional policy;
5. Be in general conformity to the Regional Spatial Strategy;
6. Be in alignment with the Sustainable Community Strategy;
7. Follow the Government's principles for community engagement in planning;
8. Be justified and founded on a robust and credible evidence base;
9. Be deliverable, flexible and the ability to be monitored.

- 1.15 The guidance makes clear that a Core Strategy should contain clear and concise policies for delivering the strategy, which will apply to the whole of the local planning authority's area or to locations within it. It should not identify individual sites, which are to be dealt with under site specific allocations DPDs or Area Action Plans. It may set out broad locations for delivering the housing and other strategic development needs such as employment, retail, leisure, community and essential public services and transport development.
- 1.16 General locations for strategic development, major transportation issues and main patterns of movement and constraints should be set out on a key diagram which will illustrate the broad strategy for the area in diagrammatic form.

### Community involvement in the new development plan system

- 1.17 The planning system places great emphasis on community involvement in particular with respect to the preparation of development plans, which Bradford Council is firmly committed to. PPS12 sets out the Government's principles<sup>2</sup> for community engagement and involvement within planning; these are:
- **Appropriate** to the level of planning;
  - **Front loading** – from the outset of plan preparation;
  - **Continuous** – part of an ongoing programme of community involvement;
  - **Transparent and accessible** – using methods appropriate to the communities concerned;
  - **Planned** – as an integral part of the plan making process.
- 1.19 The SCI sets out the Local Planning Authority's policy of involving the community in the preparation and revision of LDDs and planning applications. Regulation 25 for DPDs and Regulation 17 for SPDs set minimum requirements for community involvement<sup>3</sup>. This Engagement Plan provides the detail on how and when the community will be involved in preparing the Core Strategy DPD in line with the Council's adopted SCI and how it will comply with the minimum requirements as set out within the planning Regulations.
- 1.20 The Decentralisation and Localism Bill (2010) introduced by the Government outlined plans to give communities and neighbourhoods far more ability to determine the shape of the places in which they live through 'neighbourhood plans'. If produced, these plans must conform to the Core Strategy and other development plan documents and they would form part of the LDF.

### Aims

1.21 This Engagement Plan has been drawn up to ensure that the Core Strategy is in compliance with the Council's adopted SCI and associated statutory planning regulations and that as many different stakeholders and the wider community, as appropriate, are engaged in the process. This should ensure that as far as practicable the Core Strategy:

- Reflects the needs of the District, its communities and stakeholders;
- Is technically robust and based on sound information and evidence;
- Enjoys broad consensus.

### Objectives

1.22 This Engagement Plan will:

- Identify the stakeholders that should inform the preparation of the Core Strategy;
- Set out how these stakeholders and the local community will be able to inform the preparation of the Core Strategy;
- Establish when there will be opportunities for stakeholders and communities to inform the preparation of the Core Strategy;
- Set out how comments received will be recorded and taken into consideration as the Council works towards producing a draft plan at the Submission stage.

### Principles

1.23 In line with guidance in PPS12<sup>4</sup> there are several principles, which will underpin the approach to consultation and participation.

- Maximise the opportunities for as many stakeholders and members of the public to inform the preparation of the Core Strategy including those who would not normally have their voices heard.
- Focus the Council's resources on the existing networks and forums that are currently in place within the District.
- Provide good quality, accessible and relevant information throughout the preparation of the Core Strategy.
- Provide opportunities for meaningful and active participation in the drafting of the Core Strategy which is appropriate to the stage and which are followed up so that

participants and those contributing are clear about the difference that their involvement has made.

- Meet the requirements of the Strategic Environmental Assessment (SEA) Directive with regards to consultation.

1.24 In accordance with Section 19 (5) of the Planning and Compulsory Purchase Act 2004 the Sustainability Appraisal (SA) of the Development Plan Document will incorporate the requirements of the European Directive on Strategic Environmental Assessment (SEA) with regards to community consultation.

#### **Equality Impact Assessment (EIA)**

1.25 The Core Strategy DPD has been subjected to an Initial Equality Impact Assessment (EIA) during the preparation of the draft policies to identify any potential significant adverse impacts against any of the groups of protected characteristics. Where an unintended impact may have been likely or where potential benefits could be maximised the Core Strategy has taken these into consideration in its preparation.

1.26 The protected characteristics groups include:

- Age
- Disability
- Gender Reassignment
- Race
- Religion / Belief
- Pregnancy and maternity
- Sexual Orientation
- Sex

1.27 The Equality Impact Assessment report is a background document which is to be published as part of this consultation for comment.

1.28 Consideration of equality issues will be given during the entire consultation exercise to ensure that a representative view of the Core Strategy DPD is sought.

**PART TWO: PARTICIPATION AND ENGAGEMENT PLAN**

2.1 This Engagement Plan sets out how the general public and key stakeholders, organisations and groups will be consulted as part of the Further Engagement Draft consultation.

2.2 The consultation will last for a period of 12 weeks to allow all stakeholders and members of the public to fully assess all the consultation material.

**Consultees and key mechanisms for consultation**

2.3 A range of stakeholders will be consulted during this period of consultation. Appendix 2 provides a list of all consultees, including statutory bodies and key stakeholders, general consultees such as groups and organisations along with those who have requested to be notified of consultation on aspects of the LDF.

2.4 In order to comply with the adopted Statement of Community Involvement (SCI) a range of consultation mechanisms have been proposed to meet the principles and objectives set out in Section 1. Table 1 below sets out the key mechanisms which will be used during the consultation stage and who the target audience would be.

- 2.12 The Council is keen to minimise waste by reducing the amount of hard copies of consultation documents and so to reduce the environmental impacts of printing. - 2.13 Additional material will be produced for the area conferences, drop-in sessions and exhibition events in order to facilitate effective engagement. This will take the form of exhibition material, information and summary leaflets, visuals in the form of a DVD and PowerPoint presentations appropriate to the target audience.

#### **Targeted Consultees**

- 2.14 The consultation document and engagement material as set out in paragraph 2.6 and 2.7 will be sent to statutory consultees for comment. These bodies are set out in Section 1 of Appendix 2.
- 2.15 The Council will notify, in writing either by letter or E-mail, all other consultees and those who have indicated they wish to be kept up-to-date with progress on the LDF. These organisations and individuals are set out in Section 2, 3 and 4 of Appendix 2. These lists will be updated as and when requests are made to the LDF Group.

#### **Internal Consultation – Member Briefings**

- 2.16 The LDF group will hold regular meetings with the Portfolio Holder for Change Programme, Housing and Planning - Councillor Val Slater to ensure that the LDF has political support.
- 2.17 The Core Strategy Further Engagement Draft report will be taken to the Council's Regeneration and Economy Scrutiny Committee prior to consideration by the Executive.
- 2.18 All 90 Members of the Council, Members of Parliament (MPs) and Members of the European Parliament (MEPs) will be sent consultation documentation. They will also be offered briefing sessions with officers to introduce and explain the Core Strategy

DPD Further Engagement Draft, how this sits within the wider LDF context along with any implications within ward or constituency areas.

**External Consultation – Adjoining Local Authorities**

2.19 It is important that the Core Strategy aligns with other development plans in adjoining local authorities. The Leeds City Region Partnership is one key mechanism which is used to consider cross boundary issues and seek to align different development plan approaches. The Council will, prior to any formal consultation, seek to hold consultation meetings with key adjoining Local Authorities, including Leeds, Calderdale and Craven, to discuss the Further Engagement Draft.

**Internal Consultation – Other Council Departments**

2.20 As part of the wider consultation on the LDF internal departments within the Council will be invited to make comments on the Core Strategy documents. In addition, targeted contact will be made with key departments or officers through workshops, meetings, E-mail and telephone conversations to discuss elements of the Core Strategy. The strategic services and Departments are highlighted in Table 5 below.

### Parish Councils

2.24 Each of the 18 Parish and Town Councils within the District (as listed in Section 1 of Appendix 2) will be sent the consultation documentation for comment. They will also be invited to attend any consultation events which the Council organises as part of the wider consultation.

### Area Conferences and Drop-In sessions

2.25 Area conferences and drop-in sessions will be run with a specific area focus; these will be:

- City of Bradford (including Shipley & Baildon)
- Airedale (& Villages)
- Wharfedale
- Key areas of significant change.

2.26 Area conferences will involve an introductory presentation, followed by questions and the opportunity for members of the public to discuss key topics within the consultation documents with officers. The events will be targeted at key stakeholders, interest groups, community groups and also the public with an interest in that area.

### Topic Workshops

2.27 In addition to the area conferences there will be several workshops which will focus on key topics in more depth. These will include:

- Housing
- Employment and the economy
- Transport and Movement

- Minerals
- Infrastructure (physical, social & community and green infrastructure)

2.28 The themed workshops will be targeted events seeking the input of key stakeholders and service providers as well as local community's representation. Similar to the area events, the workshop sessions will involve presentations followed questions and the opportunity for attendees to discuss key topics within the consultation documents with officers.

**DVD Film Presentation**

2.29 A DVD film will be produced to facilitate the consultation during all of the mechanisms highlighted within this report. The DVD will include audio sound as well as subtitles to enable suitable accessibility to a range of audiences. It will be made available on the Council's website and on request.

**Press and Media Coverage**

2.30 The Council will produce press releases and provide briefings at the launch of the Further Engagement Draft consultation exercise for all locally circulating newspapers, local radio networks and where appropriate local television networks. These include:

**Community Pride**

2.31 Community Pride is a Council produced community newsletter that is distributed to every household within the Bradford District. This provides an opportunity for the LDF Group to publicise the Further Engagement Draft consultation within the wider

community. Publication within this newsletter is highly dependant upon preparation and printing timetables. Every effort will be made to attempt to capitalise on this communication method.

#### **LDF Newsletter – Plan-it Bradford**

- 2.32 The Council produces a quarterly electronic newsletter, known as Plan-it Bradford, to provide an update on the progress with the LDF and to provide notification of any forthcoming consultations. It is distributed via e-mail to contacts who have requested to be sent the newsletter. The newsletter is also available to download on the Council's website. Details of the Further Engagement Draft consultation will be presented within this document as an additional mechanism for informing stakeholders and the public.

#### **Social Media: CBMDC – Twitter Page**

- 2.33 Bradford Council has an official Twitter page: '@bradfordmdc' to promote the services and activities of the authority. The page is updated on a daily basis to alert members of the public (followers) of current local information.
- 2.34 The Council will consider the use of this social media method to promote the Further Engagement Draft consultation and any events to Bradford Council followers. The use of other methods such as Facebook via a corporate page will be considered if this is operational at the time of the consultation.

#### **Planning Aid England**



- 2.35 Planning Aid England (formally Yorkshire Planning Aid) is part of the Royal Town Planning Institute (RTPI), a Registered Charity. It provides free, independent and professional planning advice service to individuals and groups who cannot afford professional fees through a dedicated telephone service. They offer two main services; a single national Planning Advice Line (0330 123 9244); and a neighbourhood planning service which provided support in engaging with people and communities which are disadvantaged and marginalised in gaining knowledge about the planning system and how they can get involved. Local services operate through a Community Outreach Coordinator and a network of professionally qualified volunteers.

- 2.36 Throughout the Issues and Options stage for the Core Strategy DPD, Yorkshire Planning Aid has helped the Council to engaged with BME communities, older people and younger people throughout the District. Details of these consultations can be found within the Issues and Options consultation reports, as listed in Table 3 under paragraph 2.7.
- 2.37 In 2010 the Government announced that national funding for Planning Aid was to be cut and that organisations and charities would have to bid for a share of the community planning budget from 2011. As of June 2011, Planning Aid has successfully received Government funding, albeit significantly reduced; therefore their services will exist in a different form.
- 2.38 Bradford Council will continue to liaise and work with Planning Aid England throughout the preparation of the Core Strategy DPD. In addition, the Council will publicise Planning Aid England's services at its public access points, on the corporate website and will work in partnership with the organisation to increase local community involvement in the preparation of the Core Strategy.

## **PART THREE: NEXT STEPS FOLLOWING THE CONSULTATION**

---

### **Record and Publication of Consultation Responses**

- 3.1 During this consultation, the Council will receive comments and feedback through the following methods:
- Written Representations (Letters and E-mails)
  - Comments at conferences, workshops and drop-in events
  - Comments at internal and external partnership and network meetings
  - Feedback at conferences, workshops and drop-in events.
- 3.2 All written representations made during this consultation will be formally recorded in a Summary of Written Representations document. Similarly, details of any events and comments made at these will be recorded in separate Consultation Event Logs. The Council will then consider all the matters raised and provide a corporate response within a Statement of Consultation report which will document the whole consultation. Each of these documents will be a public record and will be made available to the public on the LDF website. The public will be notified that representations cannot be treated as confidential and this will be made clear throughout the consultation on letters, comment forms, information sheets and on the website.
- 3.3 Those who made written responses/comments will be sent notification once a Summary of Representations document is available on the Council's website for viewing and downloading. Those organisations and individuals who attend a drop-in session will be invited to write their contact details on a contact form. Those who fill this in will also be notified of this publication. Where the issues raised require further discussions or input from stakeholders or groups, these will be arranged as and when appropriate.

### **Next stage: Core Strategy - Submission Draft document**

- 3.4 Once the LDF Group has analysed all the comments received at the Further Engagement Draft stage, it will then commence the preparation of the Submission Document for a final formal consultation. This will draw on the Further Engagement Draft consultation making any changes which may be necessary or appropriate. The Submission Draft document will be subject to a final Sustainability Appraisal to assess the likely environmental, social and economic impacts of the Core Strategy for Bradford.
