PROPOSALS TO INCREASE THE CAPACITY OF BELLE VUE BOYS SCHOOL, BELLE VUE GIRLS SCHOOL, QUEENSBURY SCHOOL CARLTON BOLLING SCHOOL, AND THORNTON GRAMMAR SCHOOL, BRADFORD

What is being proposed and why

As you may be aware Phase 3 of the Building Schools for the Future programme is now at the planning stage and this will focus on the proposed refurbishment, remodelling and redevelopment of the above schools.

The proposed additional accommodation in each of the above schools would mean that their physical capacity would increase. The number of pupils in the Bradford district are projected to rise significantly in the next 10 years.

Although school admission numbers are decided on an annual basis the proposed enlargements would enable higher admission numbers to be set in the future enabling a larger pupil intake at each of the schools. The enlargements would also enable each of the schools to cater for additional sixth form pupils which will increase when the changes to the school leaving date come into effect.

The Consultation

Earlier this year the Council consulted on the various options for providing additional and refurbished accommodation at each of the above schools, the focus of that consultation being primarily on the building and site issues. To enlarge a school statutory proposals have to be published, and before that can happen consultation specifically on the proposed enlargement must take place with those who may be affected by the changes.

We are therefore writing to you now to formally consult on the proposals to increase the capacity of the schools set out in the table overleaf under the BSF Phase 3 Programme.

The Consultation Process

The consultation will run from Wednesday 11th November to Friday 11th December 2009.

What will happen next

The responses will then be considered by the Council and a decision made whether or not to go ahead with the changes to the capacity as proposed. If a decision is made to go ahead, formal notices would be published, during the Spring Term 2010. There would then be a four week statutory objection period during which formal representations could be made. A final decision on the proposals would then be made by the Council at the end of that period.

Assuming a decision is made to go ahead with the enlargements as proposed, and the Council were to approve proposals then the Building Programme would commence; the target completion dates for each of these schools would be 2012. This would not necessarily mean that any of the schools' admission numbers would increase to the maximum from that date, as these are determined on an annual basis. Any increased capacity would however enable higher admission numbers to be set in the future to accommodate projected increases in pupil numbers.
