ADOPTION STATEMENT

Notice is hereby given that the City of Bradford Metropolitan District Council adopted its City Centre AAP (CCAAP) and Shipley and Canal Road Corridor AAP (SCRCAAP) on 12th December 2017.

The AAPs form part of the statutory planning framework for Bradford City Centre, Shipley and Canal Road Corridor and plan for sustainable growth in these areas to 2030. The AAPs include policies and allocations for housing, employment, transport improvements, recreation and open space in line with the National Planning Policy Framework and relevant planning regulations.

The AAPs have been subject to Examination by an independent Planning Inspector, and include Main Modifications recommended by the Inspector together with a number of minor modifications proposed by the Council. The Main Modifications are set out in an Appendix to the Inspector's Report.

Any person who is aggrieved by the adopted AAPs may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the ground that

- a) the documents are not within the appropriate power; and/or
- b) a procedural requirement has not been complied with.

Any application to the High Court must be made no later than 23rd January 2018, this being the end of the period of six weeks starting with the date which the Plan was adopted.
