A number of community actions and approaches have been identified throughout the consultation stages, as detailed in Chapter 6. Monitoring, Review, Implementation; namely regarding Conservation Areas to lobby CBMDC re review/assessment of proposed extensions/new areas in Haworth & Crossroads.
