HIGHWAYS ACT 1980

AND

ACQUISITION OF LAND ACT 1981

Notice is hereby given that Public Local Inquiries in connection with the Orders mentioned below will be held by an Inspector, appointed for the purpose by the Secretary of State for Transport, beginning at 10.00 am on Tuesday 6 November 2018 for 4 days, at the City of Bradford Metropolitan District Council, The Council Chamber, Ground Floor, City Hall, Centenary Square, Bradford BD1 1HY to hear representations from remaining objectors (as defined in the Compulsory Purchase (Inquiries Procedure) Rules 2007) and statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1994), from any other persons having an interest in the land the subject of the Compulsory Purchase Order and, at his discretion, to hear representations from any other persons who may desire to appear and be heard.

The Orders are Orders which have been made by City of Bradford Metropolitan District Council under the above-mentioned Acts and submitted to the Secretary of State for Transport for confirmation and are:-

THE CITY OF BRADFORD METROPOLITAN DISTRICT COUNCIL (HARROGATE ROAD/NEW LINE JUNCTION IMPROVEMENTS) (SIDE ROADS) ORDER 2017

This is an Order under sections 14 and 125 of the Highways Act 1980, which, if confirmed, will authorise City of Bradford Metropolitan District Council to:

- a) improve highways (including raising, lowering or otherwise altering);
- b) stop up highways;
- c) construct new highways;
- d) stop up private means of access to premises; and
- e) provide new means of access to said premises,

all on or in the vicinity of the route of the classified route known as the A658 Harrogate Road which the Council are proposing to improve from a point 70 metres north east of its junction with Carr Bottom Road, south westwards to a point 25 metres south west of its junction with Stanley Street, Bradford, and

all on or in the vicinity of the route of the classified road known as the A657 New Line which the Council are proposing to improve from a point 45 metres north west of its junction with Haigh Hall Road, south eastwards to its junction with Elder Street, Bradford.

THE CITY OF BRADFORD METROPOLITAN DISTRICT (HARROGATE ROAD/NEW LINE JUNCTION IMPROVEMENT SCHEME) COMPULSORY PURCHASE ORDER 2017

This is an Order under sections 239, 240, 246, 250 and 260 of the Highways Act 1980 and under section 2 of the Acquisition of Land Act 1981 which, if confirmed, will authorise City of Bradford Metropolitan District Council to purchase compulsorily the land and the new rights over land described therein, for the purposes of:-

- a) the improvement of the A658 Harrogate Road from a point 70 metres north east of its junction with Carr Bottom Road, south westwards to a point 25 metres south west of its junction with Stanley Street;
- b) the improvement of the A657 New Line from a point 45 metres north west of its junction with Haigh Hall Road, south westwards to its junction with Elder Street;
- c) the construction of highways and the provision of new means of access to premises in pursuance of The City of Bradford Metropolitan District Council (Harrogate Road/New Line Junction Improvements) (Side Roads) Order 2017;
- d) the improvement or development of frontages to the above mentioned highways or of the land adjoining or adjacent thereto;
- e) use by the acquiring authority in connection with the improvement of highways, the construction of highways and the provision of new means of access to premises mentioned above;
- f) mitigating the adverse effect which the existence or use of the highways proposed to be improved or constructed as mentioned above will have on the surroundings thereof; and
- g) under section 40 of the Road Traffic Regulation Act 1984, and under section 2 of the Acquisition of Land Act 1981, for the purposes of relieving or preventing congestion of traffic within the acquiring authority's area, to provide off-street parking places together with means of entrance to and egress from them.

Copies of the above-mentioned Orders and of the plans referred to therein have been deposited and may be seen at all reasonable hours, free of charge, at the offices of the City of Bradford Metropolitan District Council, City Hall, Centenary Square, Bradford BD1 1HY, Eccleshill Library, Bolton Road, Bradford BD2 4SR and at Idle Library, Wright Watson Enterprise Centre, Thorpe Garth, Idle, Bradford BD19 9LD (excluding Bank and Public Holidays).

Copies of any proofs of evidence, sent to or by the promoting authority, are also available for inspection at the addresses given above from 16 October 2018.

Proceedings on the above-mentioned Orders are being taken concurrently by virtue of Section 257 of the Highways Act 1980.
