# 2. Matters which are the subject of specific areas of agreement / disagreement

### 2.1 Agreement:

- a. The site is not regarded as supporting habitat to the South Pennine Moors SPA/SAC and therefore highly unlikely to have a significant effect on the interest features of the SPA/SAC. As such there is no further assessment against the habitat regulations required;
- The Brooks Ecology Reports submitted as part of the application adequately capture the baseline habitats present on site and that the BNG snapshot report is suitable to illustrate indicative habitat losses and gains over the lifespan of the works;
- Additional information provided within the Envance 'Horn Crag Quarry Badger Mitigation Strategy' (received 24<sup>th</sup> January 2024) demonstrates that the potential for impacts to badgers can be adequately mitigated on site and can be addressed via a pre-commencement planning condition requiring the production of a badger mitigation strategy and obtaining of appropriate licenses.
- Additional conditions to be agreed for mitigation and licensing
- There are no other protected species concerns relating to the site.

### 2.2 Disagreement:

- b. Whether the Brooks Ecology Reports submitted as part of the application demonstrate:
  - Whether there has been appropriate consideration of the mitigation hierarchy in regards to the potential for avoidance of impacts to existing heathland areas;
  - Whether the proposals will result in timely net gains to

- biodiversity; and,
- Whether there is an unacceptable impact on the functionality of the Wildlife Habitat Network.

A list of Core Documents are be agreed between the Appellant and BMDC.

### 2.3 Draft additional conditions in relation to protected species mitigation:

The following works to open and operate a quarry with associated infrastructure shall not in any circumstances commence unless the local planning authority has been provided with either:

- a) a licence issued by Natural England pursuant to relevant protected species legislation
- authorising the specified activity/development to go ahead; or
- b) a statement in writing from the relevant licensing body to the effect that it does not consider that the specified activity/development will require a licence.

No development shall take place until an ecological design strategy (EDS) addressing mitigation for protected species has been submitted to and approved in writing by the local planning authority.

The EDS shall include the following.

- a) Purpose and conservation objectives for the proposed works.
- b) Review of site potential and constraints.
- c) Detailed design(s) and/or working method(s) to achieve stated objectives.
- d) Extent and location/area of proposed works on appropriate scale maps and plans.
- e) Type and source of materials to be used where appropriate, e.g. native species of local provenance.
- f) Timetable for implementation demonstrating that works are aligned with the proposed phasing of development.
- g) Persons responsible for implementing the works.
- h) Details of initial aftercare and long-term maintenance.
- i) Details for monitoring and remedial measures.
- j) Details for disposal of any wastes arising from works.

The EDS shall be implemented in accordance with the approved details and

all features shall be retained in that manner thereafter.
