The Trust support proposals to improve access within Shipley and the canal. The canal and towpath is a key component of green infrastructure that provides a car free transport route through Shipley promoting healthy lifestyles as people walk and cycle to work and school, thereby reducing congestion and pollution on the local road network.

The AAP identifies several development sites along the Leeds and Liverpool Canal. New developments in the vicinity of the canal can lead to an increased burden on the waterway infrastructure, for example by increasing the use of the towpath by pedestrians and cyclists, expectations in relation to the cleanliness and condition of the waterway or an increased risk of flooding due to surface run-off. Such impacts could result in deterioration in the quality and condition of the canal infrastructure, to the detriment of all users of the canal corridor.

As such we welcome that the Policy will ensure that new development will be required to support the implementation of local transport improvements through design and access considerations and/or developer contributions.

Such an approach is consistent with paragraph 114 of the National Planning Policy Framework (NPPF), which calls for local planning authorities to plan 'positively for the creation, protection, enhancement and management of green infrastructure.
