Notice is hereby given in accordance with the above Regulations that the City of Bradford Metropolitan District Council has published the afore-mentioned Development Plan Document and that following consultation it proposes to submit those documents to the Secretary of State for independent examination.

Title of documents	Shipley and Canal Road Corridor AAP – Proposed Main Modifications Schedule
Subject Matter	The Area Action Plan will guide the transformation of the city centre regeneration area up to 2030. It will identify the location of new development and provide detailed policies to inform decisions on planning applications. It will form the statutory planning framework for the Shipley and Canal Road Corridor as well as influencing decisions on transport, infrastructure, community facilities, economic development and future investment.
	Following consultation in 2013 on the Issues and Options and Publication Draft version in 2015/16, the Shipley and Canal Road Corridor AAP was submitted to government for independent examination on Friday 29 th April 2016.
	As part of the examination process, the Inspector has issued a number of Matters, Issues and Questions (MIQs) relating to the legal compliance and soundness of various parts of the Plan. The Council has issued responses to all the MIQs raised by the Inspector, some of which have resulted in a number of modifications being proposed. Alongside these modifications, the Inspector has also suggested a number of modifications to address any outstanding issues, which the Council have accepted and incorporated into the overall Schedule of Modifications.
	The Council is now proposing Main Modifications to the Shipley and Canal Road Corridor AAP as set out in the 'Proposed Main Modification Schedule'.
