The Trust welcomes the additional focus upon the opportunity for environmental and sustainable transport improvements and the opportunity to secure direct investment and funding to support green infrastructure enhancements.

We note that the AAP does recognise the Leeds & Liverpool Canal as Green Infrastructure. Inland waterways form part of strategic and local green infrastructure networks that provide recreational, health and educational benefits to the local community, and new development along the canal will benefit from being located adjacent to this green infrastructure in the form of providing amenity space for residents, and providing sustainable transport links through both the local area, and to the wider countryside. However, new development places additional, burdens on green infrastructure, especially upon the towing path, from increased usage. The recognition of the opportunity to seek direct investment and funding upon green infrastructure will help to mitigate these effects, and will help ensure that the canal

and towpath are protected and enhanced. This is consistent with paragraph 114 of the National Planning Policy Framework (NPPF), which calls for local planning authorities to plan 'positively for the creation, protection, enhancement and management of networks of biodiversity and green infrastructure.'
