# South Pennine Moors SPA/SAC Planning Framework Supplementary Planning Document

# **Adoption Statement**

In accordance with Regulation 14 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended), notice is hereby given that the City of Bradford Metropolitan District Council adopted the South Pennine Moors SPA/SAC Planning Framework Supplementary Planning Document (SPD) on the 4th January 2022.

## **Purpose**

The SPD provides additional guidance on the implementation of Core Strategy Policy SC8: Protecting the South Pennine Moors SPA and South Pennine Moors SAC and their zone of influence. In particular, it sets out a range of measures to mitigate against the recreational impacts of new development on the moors and provides the mechanism for calculating financial contributions to pay for this mitigation.

#### Consultation

A formal public consultation on the Supplementary Planning Document was carried out for a six-week period between 8<sup>th</sup> February 2021 and 24<sup>th</sup> March 2021. All parties whose details are held on the Council's Stay Connected database and have indicated they wish to be contacted on planning policy matters, were notified of the consultation. This included statutory bodies and organisations, local organisations, businesses and residents.

A number of modifications were made to the SPD, pursuant to section 23(1) of the Planning and Compulsory Purchase Act 2004, taking into account the representations received to the consultation. These modifications are set out in the Statement of Consultation which accompanies the SPD, and provides a summary of the main issues raised through the consultation process and how they have been addressed.

Any person with sufficient interest in the decision to adopt the SPD may apply to the High Court for permission to apply for judicial review of the decision to adopt the SPD. Such an application must be made promptly and in any event not later than three months after the date on which the SPD was adopted.
