FOREWORD

This document sets out how the Council will seek to engage the public in considering the *Issues and Options* for dealing with waste along with the identification of waste management sites within the Bradford District over the next 15 years. It sets out the aims and principles that will underpin the consultation on the Waste Management Development Plan Document (DPD) and will be referred to as the Engagement Plan.

The City of Bradford Metropolitan District Council has commissioned GVA Grimley to produce the Waste Management DPD. This DPD will form part of the Local Development Framework for Bradford.

The Local Development Framework will be a portfolio of Local Development Documents (LDDs) that will guide future growth and development in the District in the period up to 2026. The District faces some major challenges ahead arising from development pressure for new housing, retail and commercial premises and the supporting infrastructure, services and facilities required to facilitate major growth and regeneration. The first stage in preparing the LDF is the preparation of the Core Strategy DPD; this will then inform all the other Development Plan Documents to be produced as part of the LDF. The Core Strategy DPD is currently nearing its Preferred Options stage.

The Waste Management DPD will build on the strategic policy guidance relating to waste management within the Core Strategy, and will be an important tool in ensuring that the Council has sufficient and appropriate provision within the LDF to deliver the aspiration for self-sustainability in waste management over the next 15 years.

One of the key aims of the new system is to strengthen community involvement in the planning of the places in which people live and work. Importance is placed on community involvement throughout the preparation of the new Development Plan Documents but in particular in the early stages. The Government now requires all planning authorities to prepare a Statement of Community Involvement (SCI) which sets out how the Council intends to engage with the community in preparing its LDF and also how it engages with the community in dealing with planning applications. Bradford Council is committed to ensuring that everyone has an equal opportunity to play an active and positive role in considering the planning issues, which affect them and the District. The SCI for Bradford was adopted by Full Council on 8th July 2008.

This stage of consultation – Issues and Options, is the first round of public consultation that the Council will undertake to identify the key issues for Bradford in terms of waste and the possible options for future development and location. This consultation will allow the key

players within the waste industry to consider the big issues facing the District, help shape the long-term vision and ultimately the strategic policies and proposals to deliver the overall vision for Bradford.

This Engagement Plan has been developed based upon:

- Planning Policy Statement (PPS) 12 – Local Spatial Planning (2008)
- Statement of Community Involvement (SCI) (2008)
- Local Development Scheme (LDS) (2007)
- PAS – Plan Making Manual

This Engagement Plan is separated into three parts:

- **Part One** sets out the aims and principles that will underpin the consultation on the Issues and Options for the Waste Management DPD.
- **Part Two** is a consultation and participation plan that sets out how the Council will aim to meet the aims and principles in Part 1 and also comply with the adopted SCI.
- **Part Three** sets out how the consultation and engagement will be recorded and used in the next stages in developing the Preferred Options for the Waste Management DPD.

PART ONE: AIMS AND PRINCIPLES

1.0 BACKGROUND

What is a Local Development Framework (LDF)?

- 1.1 The current Replacement Unitary Development Plan (RUDP) for Bradford was formally adopted on 15th October 2005. A number of policies within this plan were saved under a Secretary of State Direction and Schedule of Saved Policies on 30th September 2008.
- 1.2 The Government introduced proposals for planning reform to speed up the planning system through the Planning and Compulsory Purchase Act 2004. This changed the current pattern of development plans. The old system consisted of a single Unitary Development Plan (UDP) covering the whole District; however under the new planning system this is now being replaced by a development plan that is made up of a series of separate documents constituting the Local Development Framework (LDF).

Local Development Documents (LDD)

- 1.3 Documents that make up the Local Development Framework are called Local Development Documents; these have to conform to the policies put forward in the Regional Spatial Strategy. There are two compulsory types of Local Development Documents; these include Development Plan Documents (DPD's) and the Statement of Community Involvement (SCI).

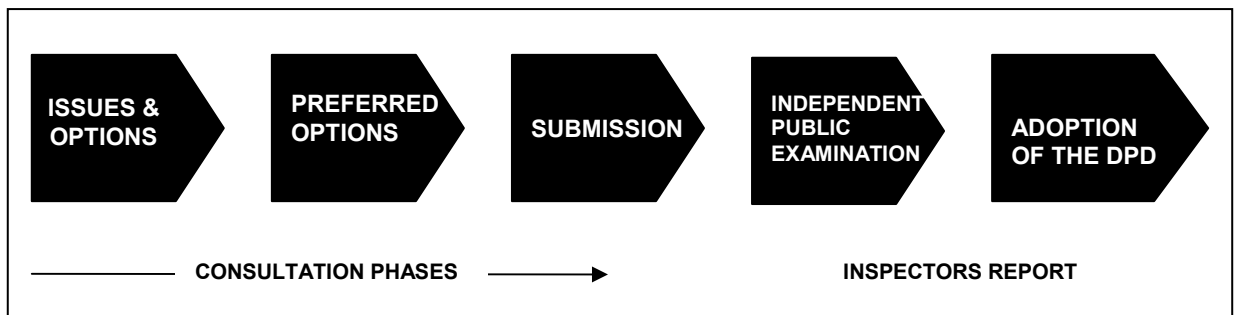
Development Plan Documents (DPD)

- 1.4 These are documents that form part of the statutory development plan for the District and are subject of a Public Examination by an independent Inspector. These include the following:

DEVELOPMENT PLAN DOCUMENT (DPD)	DOCUMENT DESCRIPTION
Core Strategy	This document sets out the spatial vision for the District, the strategic policies for guiding development, the housing requirement, and a framework for monitoring and implementing the Strategy.
Waste Management	This document sets out the spatial strategy for dealing with waste within the district. It will identify waste management sites for dealing with different stream of waste.

Site Allocations	This document identifies sites for development.
Area Action Plans	These documents set out a planning framework that is targeted at a specific area of change or conservation.
Proposals Map	This document will show the proposals for the District on an OS Map base, and will be updated as individual documents are adopted.

- 1.5 The revision of Planning Policy Statement 12: Local Spatial Planning and associated planning regulations in 2008 dissolved the need for Local Authorities to undertake consultation at both the Issues and Options and the Preferred Options stages, instead these can now be merged to form one round of public consultation. The Council has made the decision to proceed with Issues and Options consultation to identify the key issues with regards to waste management within the District and then to progress onto Preferred Options. This method will ensure that a logical approach is taken which will ensure that a 'sound' DPD is produced. The Waste Management DPD will go through the following stages as part of its preparation:



- 1.6 All DPDs will be tested thoroughly at an independent public examination to see whether they satisfy the statutory requirements for the preparation of a plan and determine if it is 'sound'. PPS12 sets out the criteria for assessing whether a DPD is 'sound'. To be sound the Development Plan Document must be justified, effective and consistent with national policy¹. One legal requirement of the plan is whether the DPD has been prepared in compliance with the adopted Statement of Community Involvement (SCI).

Statement of Community Involvement (SCI)

- 1.7 The Statement of Community Involvement sets out how the Council intends to engage the community in producing Local Development Documents that make up the Local Development Framework, and in the consideration of planning applications.

The SCI is itself a Local Development Document that is the subject of a Public Examination by an independent Inspector.

- 1.8 Bradford's SCI was adopted on 8th July 2007. All other Local Development Document's will have to comply with the requirements for community involvement as set out within the adopted SCI.
- 1.9 This Engagement Plan will set out how the Issues and Options consultation will be in accordance with the adopted SCI through an identification of who will be consulted, by what means and when this will happen. Following this consultation, a Statement of Consultation will record exactly what took place and the outcomes of all the meetings, events and comments.

What is the Waste Management DPD?

- 1.10 Planning Policy Statement (PPS) 10: Planning for Sustainable Waste Management provides guidance on how local and regional planning bodies can achieve more efficient sustainable waste management through the development of appropriate strategies for growth, regeneration and the prudent use of resources; and, by providing sufficient opportunities for new waste management facilities of the right type, in the right place and at the right time.
- 1.11 This Waste Management Development Plan Document (DPD) will build on the strategic policy guidance relating to waste management within European and national guidance, the Regional Spatial Strategy (RSS) and the LDF Core Strategy. It will be an important tool in ensuring that the Council has sufficient and appropriate provision within the LDF to deliver this aspiration for self-sustainability in waste management over the next 15 years.
- 1.12 Insofar as the DPDs are concerned, it must take into account the need to contribute appropriately to national, regional and local requirements at acceptable social, environmental and economic costs. It should be in general conformity with the RSS for the Yorkshire and the Humber.

Community involvement in the new development plan system

- 1.13 The new planning system has a greater emphasis on community involvement, which Bradford Council is already firmly committed to. PPS12 sets out the Government's principles² for community engagement and involvement within planning; these are:

- **Appropriate** to the level of planning;
- **Front loading** – from the outset of plan preparation;
- **Continuous** – part of an ongoing programme of community involvement;
- **Transparent and accessible** – using methods appropriate to the communities concerned;
- **Planned** – as an integral part of the plan making process.

1.14 The SCI sets out the Local Planning Authority's policy of involving the community in the preparation and revision of LDDs and planning applications. Regulation 25 for DPDs and Regulation 17 for SPDs set minimum requirements for community involvement³. This Engagement Plan provides the detail on how and when the community will be involved in preparing the Waste Management DPD in line with the Council's adopted SCI and how it will comply with the minimum requirements as set out within the planning Regulations.

Aims

1.15 This participation and engagement plan has been drawn up to ensure that the Waste Management DPD is in compliance with the Council's adopted SCI and associated statutory planning regulations and that as many different stakeholders and the wider community, as appropriate, are engaged in the process. This should ensure that as far as practicable the Waste Management DPD:

- Reflects the needs of the District and its key stakeholders and communities;
- Is technically robust and based on sound information and evidence;
- Enjoys broad consensus.

Objectives

1.16 This Engagement Plan will:

- Identify the stakeholders that should inform the preparation of the Waste Management DPD;
- Set out how these stakeholders and communities will be able to inform the preparation of the Waste Management DPD;
- Establish when there will be opportunities for stakeholders and communities to inform the preparation of the Waste Management DPD.

Principles

1.17 In line with guidance in PPS12⁴ there are several principles, which will underpin the approach to consultation and participation.

- Maximise the opportunities for stakeholders and members of the public to inform the preparation of the DPD including those who would not normally have their voices heard.
- Focus the Council's resources on the existing networks and forums that are currently in place within the District.
- Provide good quality, accessible and relevant information throughout the preparation of the DPD.
- Provide opportunities for meaningful and active participation in the drafting of the Waste Management DPD which is appropriate to the stage and which are followed up so that participants and those contributing are clear about the difference that their involvement has made.
- Meet the requirements of the Strategic Environmental Assessment (SEA) Directive with regards to consultation.

1.18 In accordance with Section 19 (5) of the Planning and Compulsory Purchase Act 2004 the Sustainability Appraisal (SA) of the Development Plan Document will incorporate the requirements of the European Directive on Strategic Environmental Assessment (SEA) with regards to community consultation.

PART TWO: PARTICIPATION AND ENGAGEMENT PLAN

2.1 This Engagement Plan sets out how the general public and key stakeholders, organisations and groups will be consulted as part of the Issues and Options stage of the Waste Management DPD

Consultees and key mechanisms for consultation

2.2 A range of stakeholders will be consulted during this period of consultation. Appendix 2 provides a list of all consultees, including statutory bodies and key stakeholders, general consultees such as groups and organisations along with those who have requested to be notified of consultation on aspects of the LDF.

2.3 In order to comply with the adopted Statement of Community Involvement (SCI) a range of consultation mechanisms have been proposed to meet the principles and objectives set out in Section 1. Table 1 below sets out the key mechanisms which will be used during the consultation stage and who the target audience would be.

2.9 The consultation documents will be available to view and download on the Council's website at: www.bradford.gov.uk/LDF.

2.10 Hard copies of the documents will also be made available on request by contacting the LDF Group using the contact details at the front of this report.

Targeted Consultees

- 2.11 The core documentation as set out in paragraph 2.5 will be sent to statutory consultees as well as key stakeholders. These bodies are set out in section 1 and 2a&b in Appendix 2, but will be updated as and when appropriate.
- 2.12 In addition, the Council will notify in writing those who have indicated that they wish to be kept up-to-date with work on the LDF. These individuals are set out in section 3 in Appendix 2. This list will be updated as and when requests are made.

Internal Consultation – Member Briefings

- 2.13 All 90 Members of the Council will be sent the consultation documentation. Briefing session will be offered with officers to introduce the Issues and Options paper for the Waste Management DPD and how this sits within the wider LDF context. The Issues and Options paper was also be taken to the Executive Committee for comment on 20th October and approved for public consultation. The Executive Committee also deferred the document Environment and Waste Improvement Committee for further inspection.

Internal Consultation – Other Council Departments

- 2.15 As part of the wider consultation on the LDF internal departments within the Council will be invited to make comments on the Core Strategy documents. In addition, targeted contact will be made with key departments or officers through workshops, meetings, e-mail and telephone conversations to discuss elements of the Waste Management DPD. The strategic services and departments are highlighted in Table 5 below.

Key Partnerships and Networks

- 2.16 Officers of the Local Strategic Partnership (LSP) will be invited to attend the meetings and the stakeholder event to discuss the issues and options set out in Waste Management DPD.

Parish Councils

- 2.17 Each of the 17 Parish Councils within the District (listed in Appendix 1) will be sent the consultation documentation for comment and will also be invited to attend the topic workshop.

Topic Workshop – Waste

- 2.18 A Waste Management workshop will be run which will specifically target key stakeholders and members of the waste industry; however places at the event will

also be made available should other organisations or members of the public who may wish to attend.

Press and Media Coverage

2.19 The Council will produce press releases and provide briefings at the launch of the Issues and Options consultation for all locally circulating newspapers, and where appropriate local radio networks and local television networks. These include:

LDF Newsletter – Plan-it Bradford

2.20 The LDF Group produces a quarterly electronic newsletter to provide an update on the progress with the LDF and to provide notification of any forthcoming consultations. It is distributed via E-mail to contacts who have requested to be sent the newsletter and is also available to download on the Council's website. Details of the consultation on the Waste Management DPD Issues and Options consultation will be provided within this newsletter as an additional mechanism for informing stakeholders and the public.

PART THREE: NEXT STEPS

Record and Publication of Consultation Responses

- 3.1 The Council will record discussions of the workshop events and also any discussions which take place at key partnership and network meetings. These will be a public record. The issues raised at these workshop events together with all of the formal written responses will then be logged and summarised in a consultation report. The Council will then consider the matters raised and its proposed response.

- 3.2 Those who have made comments or were engaged in a workshop will be sent the summaries and the Council's response; these will also be available on the Council's website for viewing and downloading. Where the issues raised require further discussions or input from stakeholders or groups, these will be arranged as and when appropriate.

Next Stage: Waste Management DPD – Preferred Options

- 3.3 Following the Issues and Options consultation, the Council and external consultants - GVA Grimley will then take into consideration all the comments and written representations before preparing the Preferred Options Report for further consultation in 2010.
