ADOPTION STATEMENT

Notice is hereby given that the City of Bradford Metropolitan District Council adopted its Waste Management DPD on 17th October 2017.

Upon adoption, the Waste Management DPD will form part of the statutory plan which sets out the proposed approach to managing waste in a sustainable manner to 2030. It includes policies and allocations for the management of waste in line with the national waste strategy and relevant European regulations. It deals with all types of waste including Local Authority Collected Waste (LACW), Commercial and Industrial (C&I) Waste, Construction, Demolition and Excavation Waste (CDEW), Agricultural Waste, Hazardous Waste, and Low Level Radioactive Waste.

The Waste Management DPD has been subject to Examination by an independent Planning Inspector, and includes Main Modifications recommended by the Inspector together with a number of minor modifications proposed by the Council. The Main Modifications are set out in an Appendix to the Inspector's Report.

Any person who is aggrieved by the adopted Waste Management DPD may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the ground that

- a) the documents are not within the appropriate power; and/or
- b) a procedural requirement has not been complied with.

Any application to the High Court must be made no later than 28th November 2017, this being the end of the period of six weeks starting with the date which the Plan was adopted.
