1.0 INTRODUCTION

- 1.1 The Planning and Compulsory Purchase Act 2004 brought about a major change to the planning system, in particular to planning policy and how development plans are to be prepared. More recent reforms through the Localism Act and the national Policy Framework (NPPF) reinforce the development plan led system and the need for an up to date Local Plan. The adopted Replacement Unitary Development Plan (RUDP) (2005) will, in time, be replaced by the Local Plan for the Bradford District as set out in the updated Local Development Scheme approved in July 2014.
- 1.2 When preparing documents which will form part of the Local Plan, the Council must carry out public consultation with local communities and stakeholders in order to gauge views on the plan and its soundness, legal compliance and whether it meets the duty to co-operate. The minimum requirements which all local authorities must comply with are currently set out within the Town and Country Planning (Local Planning) (England) Regulations 2012.
- 1.3 Bradford Council commenced the preparation of the Core Strategy Development Plan Document (DPD) in 2006 and has since undertaken three rounds of formal public consultation and engagement to establish the key issues and options for the District and to test the proposed preferred option. This was followed by a further pre-submission consultation on the Publication Draft Plan.

Purpose of this document

- 1.4 This document summarises the entire consultation process which has been undertaken as part of the preparation of the Core Strategy DPD through to Submission stage. It forms the 'consultation statement' which is required under Regulation 22 of the Town and Country Planning (Local Development) (England) Regulations 2012.
- 1.5 The Council has, at each formal stage of the plan preparation process, produced a Statement of Pre-Submission Consultation that provides an overview and record of each representation process and the consultation outcomes at that stage. Each report has been considered and approved by Bradford Council's Executive Committee and Portfolio Holder for Housing,

Planning and Transport. This document should be read alongside the consultation report for each key stages of consultation.

- 1.6 The consultation reports comprise of (in order of publication):
 - Statement of Pre-Submission Consultation Issues and Options and Further Issues and Options (2011)
 - Statement of Pre-Submission Consultation Further Engagement Draft (2013)
 - Statement of Pre-Submission Consultation Publication Draft (2014)

2.0 WHEN DID CONSULTATION TAKE PLACE?

- 2.1 The Core Strategy DPD has been prepared through a number of production and consultation stages, as listed below:
 - 1 Pre-production scoping and evidence gathering (pre 2007)
 - 2 Consultation on Issues and Options (2007)
 - 3 Consultation on Further Issues and Options (2008)
 - 4 Consultation on Further Engagement Draft (2011-2012)
 - 5 Consultation on Publication Draft (2014)
- 2.2 At the pre-production scoping and evidence gathering stage, the Council prepared a Draft Sustainability Appraisal Scoping Report which brought together baseline data and information on a range of other plans, policies and programmes in a systematic and summarised form. This report also identified the Draft Sustainability Appraisal Objectives that have been used in the Initial SA.
- 2.3 Early engagement work was initially undertaken in 2007 on the Issues and Options. The Council sought the views of key stakeholders, community groups and residents with regards the issues faced by the District and how these should potentially be addressed in the Core Strategy. The Council invited representations from bodies and persons over a six week period from Friday 16th February until Friday 30th March 2007.
- 2.4 In light of comments received to the initial Issues and Options papers and also the changes proposed to Regional Spatial Strategy (RSS) by the Secretary of State, the Council had determined that in order to ensure a sound process that further consultation was required. This explored a revised vision, which sought to be more spatial and aligned to the Sustainable Community Strategy. It also provided more detail on the spatial options for accommodating development in light of the growth now envisaged by the revised RSS.
- 2.5 The **Further Issues and Options** consultation stage in 2008 presented four spatial options for the direction of future growth within the District. The Council invited representations during a formal six week consultation period

from 15th January until 20th March 2008. Additional consultation work was undertaken with the help of Yorkshire Planning Aid (now Planning Aid England) with hard to reach sections of the local community.

- 2.6 In taking forward the Core Strategy, the Council had regard to the issues from the Further Issues and Options consultation and developing national guidance and good practice (e.g. Planning Advisory Service, Planning Officers Society and recent Inspectors reports). In particular it sought to ensure a robust and proportionate approach to the underpinning evidence base on which to develop and test the Core Strategy approach.
- 2.7 In 2011, the Council presented a proposed draft Core Strategy the Further Engagement Draft, which contained strategic policies for public consultation. It was the intention of the Council to seek the views of bodies and persons with an interest in the District with regards to the adopted approach, content and policies, along with the evidence base which supported the draft Plan. The Council undertook an extended twelve week public consultation on the Further Engagement Draft from Friday 28th October 2011 until Friday 29th February 2012.
- 2.8 The Council completed work to revise the Core Strategy in light of comments to the Further Engagement Draft, new national guidance, and new and updated evidence. The early part of 2013 was spent finalising several key technical studies which were key to the preparation of the Publication Draft.
- 2.9 In 2014 the Council prepared the final proposed plan the **Publication Draft**, for consultation. This stage formed the final plan preparation stage before Submission. The Council published the Plan for written representations for six weeks from Monday 17th February until Monday 31st March 2014.
- 2.10 The representations received during the Publication Draft consultation were analysed by the Council and the main issues noted (see: Publication Draft Statement of Pre-Submission Consultation, 2014). The Core Strategy as drafted is deemed sound by the Council and a decision to submit to the Secretary of State and to proceed with Examination was taken.

3.0 REGULATION 22 (1)(C)(i) – WHICH BODIES DID THE COUNCIL INVITE TO MAKE REPRESENTATIONS?

- 3.1 The Council's main consultation lists comprises a number of bodies and persons of which is made up of the specific and general bodies outlined in Part 1, Regulation 2 (1) Interpretation (see Table 1 below); and those persons who wish to be notified about the preparation of the Plan.
- 3.2 The consultation lists accords with the Council's Statement of Community Involvement (SCI) *(Submission SCI 2006 and adopted SCI July 2008)* which also sets out the specific, general and other consultation bodies would be consulted during the preparation of the Core Strategy DPD.

4.3 The Council requested representations be sent either by post or E-mail to the address specified in the consultation document and/or the representation form.

5.0 REGULATION 22 (1)(C)(iii) – SUMMARY OF THE MAIN ISSUES RAISED BY THE REPRESENTATIONS

Issues and Options (2007)

5.1 A total of 66 representations were received primarily from specific and general bodies. A further 219 people attended various consultation workshop events and provided comments on their perceived issues and options for the District.

Further Issues and Options – Waste Management and Topic Paper 7: Environment (Minerals) Update (2008)

5.2 This stage of consultation aimed to target key interested bodies in waste management and minerals. A total of 13 representations were received in relation to consultation on the Further Issues and Options Waste Management; and 3 representations were received to the Topic Paper 7: Environment (Minerals) Update (2008).

Further Issues and Options (2008)

5.3 Following the emerging Draft Regional Spatial Strategy the Council presented four spatial options for growth and development at this stage. These indicative map images stimulated debate within communities and for stakeholders and as a result the Council received a total of 317 representations, in addition to 107 'Option Choice Comment Forms' handed out at area workshop events.

Summary of Issues Raised at the Issues and Options Stage

- 5.4 The main high level issues highlighted during the Issues and Options consultation stage between 2007 2008 are summarised below:-
 - **Issue 1:** General support for the overall vision and objectives within consultation documents, however this needs to be made more locally distinctive to Bradford.
 - **Issue 2:** Mixed response to the four spatial options (presented at the Further Issues at Options Stage). Respondents generally favoured a combination of the options presented.

- **Issue 3:** General support for the approach to focus development within sustainable locations and within the existing built up areas before considering development of greenfield sites.
- **Issue 4:** Support for the protection of the exiting Green Belt and other areas of the District's countryside with high quality landscape character and biodiversity value.
- **Issue 5:** There is a need to address the issue of affordability of future housing (based on local need) and the size and types of homes across the District.
- **Issue 6:** Infrastructure and connectivity is a key issue across the District and needs to be fully assessed as to what is, and will be required before or at the start of any major new development.
- **Issue 7:** There is a need for improvements to public transport systems across the District.
- **Issue 8:** There is strong ongoing support for the need to maintain local distinctiveness through the enhancement and protection of both the natural and built environment.
- **Issue 9:** The role of Bradford City Centre, both within the District and the Leeds City Region, should be reinforced and strengthened to create a quality retail offer with plenty of employment opportunities through regeneration and enhancement schemes.
- **Issue 10:** Support for focused regeneration and economic development with the Airedale corridor.
- **Issue 11:** A more prominent and positive approach is needed to overarching issues such as climate change, greater production of renewable energy and sustainable design in the overall strategy.

- **Issue 12:** Flood risk is an important issue within the District when considering the future location of housing and employment development and the Strategic Flood Risk Assessment.
- **Issue 13:** In general, there is need for a more robust evidence base to inform and provide a justification for the spatial options presented and to be made available.
- 5.5 Following on from the Issues and Options consultations the Council developed further the technical evidence base on which to inform the preferred development strategy and associated policies. The following studies were used to inform the Further Engagement Draft stage:
 - Affordable Housing Economic Viability Assessment (2011)
 - Core Strategy Baseline Analysis Report
 - District Transport Study (2010)
 - Employment Land Review and Update (2008 and 2011)
 - Gypsy and Traveller Accommodation Assessment (2008)
 - Housing Requirement's Study (2008)
 - Local Economic Assessment (2011)
 - Local Infrastructure Plan
 - Open Space and Recreation Study (2006)
 - Retail and Leisure Study (2008)
 - Strategic Flood Risk Assessment Level 1
 - Strategic Housing Land Availability Study (2011)
 - Strategic Housing Market Assessment (2010)
 - Urban Potential Study
- 5.6 These studies where appropriate were themselves developed in consultation with key stakeholders.

Further Engagement Draft (2011)

5.7 The Council received a total of 1,255 representations from specific, general and other bodies and persons. The sharp increase in representations received during this consultation reflected the publication of four spatial

distributions of housing maps which prompted media and public attention and discussions.

- 5.8 The main issues raised by the representations at this stage are summarised below:
 - **Issue 1:** Scale and distribution of development.
 - **Issue 2:** Need to support regeneration and use of previously developed land.
 - **Issue 3:** Need to safeguard green belt and green space.
 - **Issue 4:** Impact on settlements and communities of scales of development.
 - **Issue 5:** Need to protect and manage key assets including natural and built environment.
 - **Issue 6:** Need for adequate infrastructure (transport, education and utilities) to support development.
- 5.9 Following the Further Engagement Draft consultation, further work was undertaken to the evidence base. In addition to the evidence listed in paragraph 5.5 above, the following studies were updated for the next stage – Publication Draft; these included:
 - Bradford Growth Assessment (2013)
 - Core Strategy Baseline Analysis Report (ongoing)
 - Employment Land Review Update (2012)
 - Housing Requirements Study (2013)
 - Local Infrastructure Plan (2013)
 - Retail and Leisure Study (2013)
 - Strategic Flood Risk Assessment (2014)
 - Strategic Housing Land Availability Assessment (2013)
 - Strategic Housing Market Assessment Update (2013)

- 5.10 Work was also undertaken on the Habitats Regulations Assessment (HRA) following a screening report undertaken by consultants.
- 5.11 The further evidence work was used to inform the refined development strategy and associated policies. Work was also undertaken as part of the test of compliance with the newly published NPPF in 2012 and work to discharge the Duty to Cooperate.

6.0 REGULATION 22 (1)(C)(iv) – HOW THE CORE STRATEGY WAS CHANGED AS A RESULT OF CONSULTATION

- 6.1 Comments received under Regulation 18 (formally Regulation 25) at the Issues and Options stage, including comments received from the Further Engagement Draft consultation provided a basis to help inform the preparation of the Core Strategy Publication Draft document. The comments were considered and reviewed by the Council's Development Plan teams and a way forward agreed in relation to the broad strategy and policy areas.
- 6.2 The Council used the representations received under Regulation 18 to prepare the Core Strategy Publication Draft. Between the key stages the Council tested the issues raised with the evidence base which was developed in line with both national guidance and local circumstances throughout preparation. The local evidence was a key determinant of the final development strategy and approach. The representations helped shape the detail within the context of the local evidence and national policy.

7.0 REGULATION 22 (1)(C)(v) – THE NUMBER OF REPRESENTATIONS MADE PURSUANT TO REGULATION 20 (PUBLICATION DRAFT) AND A SUMMARY OF THE MAIN ISSUES RAISED IN THOSE REPRESENTATIONS

- 7.1 The Council published the Publication Draft for written representations on 17th February 2014 for six weeks, ending on 31st March 2014 in accordance with Regulations 19 and 20.
- 7.2 The Council received a total of 572 written representations in relation to the Publication Draft.
 - 522 of these were duly made and submitted within the set deadline (in accordance with Regulation 20);
 - 1 duly made representation submitted by email included an attached file which could not be opened.
 - 1 part of 1 duly made representation was withdrawn.
 - 1 respondent made two identical representations, only one of these has been counted.
 - 49 representations were received by the council after the formal deadline and therefore were not duly made.
- 7.3 The consultation process undertaken by the Council on the Publication Draft is recorded in the Summary of Pre-Submission Consultation (2014).
- 7.4 The summary of the issues raised in the representations is included within the Statement of Pre-Submission Consultation report mentioned above. The main issues raised during the consultation and the Council's response are summarised below:

7.5 Issue 1: Plan Period and Local Plan Documents

A number of the respondents raised concern about the Plan period linked to the delay in making allocations in line with the Core Strategy, which will only be completed by 2017. It is suggested that the plan period is extended to reflect this beyond 2030.

7.6 Council's Response

The Local Development Scheme anticipates that the full set of DPDs being in place by April 2017 with the adoption of the Allocations DPD. The Core Strategy provides a clear 15 year plan period for strategic planning purposes from date of its anticipated adoption. Given the scale of the anticipated uplift in housing delivery and also the uncertainty of long term housing projections it is clear that the monitoring of the plan is bound to point to the need for its review well within its period to take account of housing outputs and future household projections.

There is no requirement within the NPPF to tie a 15 year plan period to the expected date of adoption of an Allocations DPD. Indeed the NPPF doesn't even require a 15 year plan period as in some cases the NPPF allows for Local Planning Authority's to adopt a different plan period if local circumstances are appropriate.

7.7 Issue 2: Duty to Cooperate

Concerns are raised by a number of respondents at the lack of evidence of the Council meeting the new 'Duty to Cooperate' in particular in terms of the scale and location of new development, green belt change and impact on and future investment in infrastructure.

7.8 Councils Response

Section 2 of the Core Strategy sets out the strategic context in particular the Leeds City Region as well as a spatial portrait which identified key issues for the District as well as wider linkages and cross boundary issues.

The vision, objectives and core policies recognise and identify strategic issues and set out the approach to cross boundary issues including an explicit policy SC3 to embed this into ongoing work.

The evidence produced in support of the plan has sought to understand relevant strategic and cross boundary issues in particular work on the Local Infrastructure Plan.

The Council has set out in the Duty to Cooperate Statement how the Core Strategy preparation has met the legal duty in terms of ongoing engagement with key bodies as relevant to their role and matters dealt with in the Core Strategy. The Statement also sets out how the work on the key strategic issues has evolved and how bodies have been engaged and to what effect in terms of the approach in the submitted Core Strategy.

The Statement sets out the agreed approach across the Leeds City Region (LCR) including the approved Statement of Cooperation and the template of strategic issues and how they have been dealt with and any mitigation or further / ongoing work linked to subsequent plans, which was approved by the LCR Portfolio Holders in October 2014.

Many of the issues raised by those making representations will be picked up under the more detailed subsequent Development Plan Documents linked to allocations which will be subject to further work with duty to cooperate bodies as relevant to those plans.

7.9 Issue 3: Housing requirement

Representations have been made which suggest the housing requirement set out in the plan (Policy HO1) should be higher based on alternative model projections and the need to better align with economic ambitions in particular the job projections.

Other representations raise concerns that the housing requirement is too high and should be reduced based on various grounds including the ability of the market to deliver the housing.

7.10 Council's Response

The Housing Requirement Study (February 2013) was commissioned by the Council and undertaken by consultants GVA & Edge Analytics. The studies aim was to objectively assess the level of housing required in the District. It used a range of data including government population and household projections and regional economic projections.

A further Housing Requirement Study Addendum Report was published in August 2013. This updated the above report to take account of the issuing of the Government's interim 2011 based household projections. Following the revocation of Regional Spatial Strategy the Leeds City Region commissioned a series of studies to better understand the strategic housing issues across the city region and support Councils in the discharge of the Duty to cooperate in terms of housing following on from the commitment noted in the Interim Strategy Statement.

Edge Analytics were commissioned to produce 3 phases of work. Phase 1 was developed a common methodology for the objective assessment of need at both region wide and individual local authority levels. Phase 2 focused on the LPAS which had already undertaken work to establish a local objectively assessed need such as Bradford, as noted above. This recognised that while authorities within the LCR are at very different stages of plan development, the Leeds City Region sought to understand the approaches adopted by each authority to determining objectively assessed need and as far as practicable seek to align methodologies.

The Phase 2 report provides a review of the methodologies, data inputs, assumptions and resulting scenario outcomes that have informed the assessments of need in each of seven LCR local authorities: Bradford, Calderdale, Craven, Leeds, Selby, Wakefield and York.

The review into Bradford's HRS found it to be robust and in line with the broad principles for assessing need advocated by the phase 1 report. It did however recommend that the scenarios presented in the HRS should be updated using the most recent economic assumptions, including:

- Economic activity rates from the 2011 Census
- Commuting Ratio from the 2011 Census
- Unemployment rates which reflect economic 'recovery'.

It was also recommended that the 2012-based sub-national population projections should be considered as the new 'official' benchmark scenario. Additionally, the jobs-led scenario should be updated using the most recent (June 2014) employment forecast from the Yorkshire and Humber Regional Econmetric Model (REM). For all LCR Authorities, Edge Analytics have recommended that the household growth implications of the 2012-based household model be assessed when available.

In response to the report and to respond to some of the representations to the Publication Draft the Council commissioned a further Housing Requirement Update report from Edge Analytics.

The conclusions of the further update report confirm the robustness of the objectively assessed housing need work which has informed the housing requirement and its appropriateness in line with national guidance.

7.11 Issue 4: Housing Distribution

Concern has been raised in relation to the housing distribution (policy HO3) and impact of scales of development in several settlements in particular Wharfedale and South East Bradford. This relates to impact on infrastructure, landscape, green belt and local character.

Other representations object to the reduced housing targets in Wharfedale and associated downgrading of Ilkley and Burley-In-Wharfedale in the settlement hierarchy (policy SC4) in particular as a result of the Habitats Regulations Assessment.

7.12 Council's response

The Core Strategy is seeking to positively plan to meet its objectively assessed housing need. It is proposing to release land for over 42,100 new homes and planning to do so via the creation of new growth areas, the most notably within the Shipley and Canal Road Corridor and via the regeneration of the City centre and also through the creation of a new urban extension at Holme Wood. Positively planning for need involves not only providing for the right number of new homes but as far as possible locating those homes in or close to the areas of greatest need. Those housing needs are most acutely focused in the areas which are likely to see the greatest levels of population change which are in the larger urban centres and not in the smaller villages.

In meeting this need, the plan has sought to ensure a sustainable development strategy in line with NPPF Core Planning Principles. This

strategy recognises the differing roles of settlement and their abilities to develop in a sustainable way. Policy SC4 sets out broad planning strategy as to how different categories of settlement can and should grow. This is supported by more detailed guidance in the sub area policies.

The supporting text to Policy Ho3 sets out the approach adopted with regards to housing distribution. The distribution is based upon the Core Policies in particular SC4 which sets out the settlement hierarchy. Further information on the approach to distribution is set out in background Paper 2 Housing part 1 published in support of the Publication Draft.

Further work has been undertaken in light of the comments on the HRA which is set out below.

7.13 Issue 5: Green Belt review

Whilst the Plan sets out the approach to green belt (Policy SC7) respondents raised concerns about the need for a full review of the green belt rather than a selective review. Other respondents raise concerns about the exceptional circumstances necessitating green belt change as well as the impact on settlements and green belt function. Objections challenge and question whether there is a need and/or exceptional circumstances for green belt release to meet housing needs, this came mainly from respondents concern broadly from developers as to the scope and nature of green belt review proposed which is set out in Policy SC7

Related concerns have been raised as to the need for urban extensions in particular the identification of Holme Wood in this respect.

There is also concern that the reviewed green belt will not meet NPPF requirements to last well beyond the plan period and in this respect suggest that the Core Strategy should seek to set out the need to designate safeguarded land in the Allocations DPD.

7.14 Council's Response

Policy HO2 together with the Council's Housing background Paper clearly set out the evidence which indicates that there are exceptional circumstances which justify releasing green belt to meet the objectively assessed needs for new homes in the District.

Policy HO5 makes clear that the Local Plan seeks to ensure non green belt land is maximised where practicable and appropriate.

In addition, HO7 which seeks to ensure that in the site selection process the use of green belt land is minimised.

The Housing Requirement for the plan period cannot be met in full without the use of land currently designated as Green Belt. Based upon the SHLAA update 2013 there may be a need for up to 11,000 dwellings to be delivered on land formerly Green Belt.

Having established that the land supply in non green belt locations is not available to meet the District's needs the Council have then commissioned a District wide growth assessment. This has confirmed both that there are sustainable locations within the green belt for growth and that there are areas where the green belt can be changed without leading to the undermining of the role of the green belt either locally or strategically.

NPPF paragraph 47 makes clear that Local Plans should meet their objectively assessed housing need in full. Paragraph 82 allows for the review of Green Belt boundaries under exceptional circumstances through the preparation of the Local Plan.

Policy HO5 makes clear that the Local Plan seeks to ensure non green belt land is maximised where practicable and appropriate.

Policy SC7 has been drafted to ensure that the key purposes of green belt as well as any strategic role it performs are considerations in any changes. The detailed changes will be undertaken in the Allocations DPD.

The review will be 'selective' in the sense that it will only be undertaken in terms of the identified exceptional circumstances in order to identify land to meet the unmet needs with regards to the development strategy set out within the plan as whole. It is also noted that land supply indicates change is required to Green Belt in most settlement but not all settlements.

While NPPF paragraph 83 states that when defining or reviewing green belt boundaries LPAs need to have regard to the intended permanence in the long term, so that they should be capable of enduring beyond the plan period.

Paragraph 85 only requires 'safeguarded land' between the urban area and the Green Belt, in order to meet longer-term development needs stretching well beyond the plan period where necessary. There is no absolute requirement to automatically allow for safeguarded land under paragraph 85. In this context each plan must tailor their approach to the circumstances at the time

Unlike the RUDP the Core Strategy has determined to release land for a full 15 year period rather than a more limited 10 year release with additional safeguarded land.

Land supply is sufficient to meet the plan requirement in full without the reliance on other sources such as windfalls. This will make contribution albeit at lower scale than previously within the plan period and allow the allocated supply to last beyond the plan period.

The plan is already proposing green belt change of a significant scale. Approximately land for 11,000 dwellings based on the current evidence. To go beyond this which would be required by the allocation of Safeguarded land would not be appropriate at this stage in terms of scale of change in advance of wider strategic review of green belt across the Leeds City Region.

There is also a constrained land supply based on current evidence and also uncertainties as what any future need may be beyond 2030.

7.15 Issue 6: Viability

A number of comments have been received raising concern over the deliverability of the development strategy due to the cumulative impact of the policy requirements on the viability of development. In particular concerns around the requirements for affordable housing, and proposed design standards

7.16 Council's Response

The Council recognise that delivery of the Core Strategy will be challenging and the viability issues that exist across some parts of the District. The Core Strategy therefore includes a range of policies and identifies a range of funding, delivery models and approaches to support implementation and delivery.

The preparation of the Core Strategy policies has reflected the findings of a wide range of evidence base, including viability assessments at key stages. In line with NPPF a viability assessment was made of the Further Engagement Draft which informed, changes to the Publication draft in light of viability and where relevant other technical evidence. A final Viability Assessment has been produced in support of the Publication Draft Core Strategy.

The Core Strategy allows for flexibility in terms of viability where evidenced on a case by case basis in relation to several policy requirements.

The NPPF paragraph 174 requires Local Plans to facilitate development throughout the economic cycle. Policy ID2 sets out the Council's approach for considering viability issues in the determination of planning applications where site specific circumstances mean that a scheme will not be able to be developed viably with the policy requirements in the Local Plan.

7.17 Issue 7: Habitats Regulation Assessment (HRA)

There are a number of representations which raise concerns about the legal compliance and evidence presented in the HRA to support the measures adopted. Concerns have been raised about soundness in relation to the influence of the HRA over levels of development in Wharfedale.

Other representations have been received which support the HRA work and raise concerns about the level of development in settlements close to the South Pennine Moors SPA/SAC.

7.18 Council's Response

The Council has undertaken further work with its consultants Urban Edge in consultation with Natural England in order to address some of the issues raised at Publication Draft stage.

A revised HRA report has been produced in support of the submission of the Core Strategy.

7.19 Issue 8: Infrastructure delivery

A significant number of respondents raise concerns about both the adequacy of existing infrastructure as well as evidence of how improvements and new infrastructure to support growth will be delivered.

7.20 Councils Response

The Council has prepared a Local Infrastructure Plan (LIP) which acts as a key evidence base to inform the Core Strategy. The LIP has highlights relevant infrastructure issues and provides a capacity assessment i.e. what infrastructure are there and what will be required to support development over the Local Plan period and how it could be implemented (through a detailed Infrastructure Delivery Schedule). It is envisaged that new infrastructure is delivered using a combination of public and private sector funding to enable developments in key housing and economic growth areas.

Further work may also be required to understand how gaps in funding can be resolved and the mechanisms by which the Council and its partners can secure public and private financing. This work will involve appraising existing funding streams and evaluating the use of alternative mechanisms such as the Community Infrastructure Levy (CIL).

In partnership with all public and private infrastructure partners, the future need and delivery of new infrastructure will be explored and site opportunities for new or enhanced infrastructure will be identified through the other DPDs.

Planned infrastructure is set out in the Infrastructure Delivery Schedule of the LIP. This will be updated by the Council when necessary in order to reflected future plans and programmes of key infrastructure providers.
