I am detailing my objection to the green belt protection being removed, the loss of countryside and the huge risk to Tong valley as a whole through the proposal of a major highway, housing and associated developments. I am not presenting any objection to the proposal for 900 homes to be built within or adjacent to Holme Wood as this is within the natural boundary and is an acceptable proportion for Tong ward to provide towards Bradford housing strategy.

I am questioning the legal compliance as local plans need to be driven by the core strategy and this process was incorrectly followed; Tong and Holme Wood NDP fails to meet the requirements of the Localism Bill.

<u>Duty to Co-operate</u>: there is no evidence that Bradford Council has met the required duty to co-operate and this appears to have been neglected throughout this process.

There is no evidence that Bradford has adequately cooperated with adjacent authorities; this has not been consistent or sustained. The geographic nature of this plan means that Leeds land surrounds a significant proportion of this development. The objections from Leeds City Council to Tong and Holme Wood NDP and the Core Strategy LDF FED have not been taken into account.

Bradford CC has not met the required duty to co-operate regarding green belt designation and how this separates the vast urban conurbations of Leeds, Bradford and Kirklees.

Consultation should extend to include residents in all areas adjacent to this development. A number of people outside Bradford authority will be directly affected, such as the potential increased risk of flooding to Pudsey beck and the Troydale area plus the traffic and infrastructure requirements which will impact significantly on Leeds and Kirklees.
