- Where is the documentary evidence in the DPD of how and with whom Bradford has co-operated during the preparation of the Core Strategy?
- In particular there is no sign of any co-operation and agreements with Leeds Council, despite the sensitive geographical adjacency of the green belt protected land that separates them. In fact Leeds Council has objected to both the Tong and Holme Wood NDP and to the Core Strategy LDF FED – so presumably this essential requirement has just then been conveniently ignored in the Core Strategy process.
- An urban extension of this size would require co-operation with numerous public bodies, for example health authorities, education, water companies, roads and transport, both within the area and in adjacent areas such as Leeds and Kirklees. There is no evidence of this very important co-operation requirement in any of the documentation, which given the scale of the proposed development also throws into question the soundness of the whole plan.
