It is difficult to recognise ILKLEY, a small town in WHARFEDGE with unique features of the river WHARFE at the base of the valley of ILKLEY MOOR & the tourist attraction of the Gw and CAFF Rocks at the Southern aspect.

There is very little local employment other than retail & hotels, restaurants, cafés which support ILKLEY as a visitor attraction and which are staffed largely from outside ILKLEY.

ILKLEY RESIDENTS mostly work away from ILKLEY, but participate in ILKLEY Theatre, Festivals & Sporting Activities and Societies.

There is no hospital or emergency medical facilities, and schools are full, so more capacity is needed.

The Plan should recognise that ILKLEY is a Jewel in Yorkshire's crown which should be enhanced to the economic benefit of ILKLEY. ILKLEY'S environment has inspired the STANZA STONES poetry on ROADSIDE MOOR, recognised internationally in 2013. Bradford Council has made grants to 'Friends of Ilkley Moor' to safeguard the environment & to promote its historical features. The Middleton side of ILKLEY is bordered by agricultural pasture, Middleton Moor & Bournsley with its wild life of curlew & lapwing & hares. The unforgettable call of the curlew is heard the year round here. It is vital to protect Green Belt here.

The significant volume of new housing has been designated to Courthouse way opposite the sports field in spite of the fact that every year this is subject to flooding in winter or sometimes in summer. In 2014 it was standing water for 7 weeks ending the beginning of March.

Further, there is no mention of an assessment of the capacity both of storing sufficient water to supply 800 extra homes and of the sewerage delivery system which was installed approx 90 years ago. This is in need of an urgent review.
