Core Strategy DPD Publication Draft. The Policy SCP 3 (SC3) Working together does not comply with paragraphs 28, 37, 47, 48, 52–54, 77, 80, 81, 82, 111, 112, 120, 128, 158, of the National Planning Policy Framework of preserving the green belt and the best and versatile farmland it encloses.

There is no corresponding infrastructure planned to deal with the consequences for extensive new housing developments.

No new schools are planned for the increase in population. Ilkley Grammar School is already over subscribed with no post 16 education in the town for all but the high achievers. Primary school children are being asked to travel to Silsden because the schools are full.

It is recognized by both Bradford and Leeds that the A65, the only main road through the Wharfe Valley, is congested and at over capacity. There are no options for a new road. Trains are also at over capacity, more carriages cannot be added as platforms are not long enough. Parking for trains and buses is sparse and surrounding streets are full of commuter's parked cars.

The town is at saturation point and cannot be described as a Principal town with the ability to grow.

My comments in italic.

Strategic Core Policy 3 (SC3): Working Together Planning decisions as well as plans, strategies, investment decisions and programmes should be based on:

A.Effective collaboration between the Council, adjoining local planning authorities, the District's Town and Parish Councils, partners and communities within the District Leeds City Region and beyond, particularly to:

1. Support the renewal and regeneration of urban and rural areas.

COMMENT: Ilkley is a unique thriving rural dormitory town at the edge of the Bradford District. To extend the town would mean building on green belt and creating an urban sprawl with is in conflict with the Government's policy of protecting the green belt and preventing urban sprawl. Eric Pickles, Sec of State, House of Commons meeting 17 Sept., 2012. "The green belt is an important protection against urban sprawl, providing a green lung around towns and cities." Also see NPPF Paras 80, 81 & 82.

2. Address low and high housing demand.

COMMENT: We are told by Nick Boles, Minister, that large development is required to meet the needs of migrant workers and thus a rise in our population. Daily Mail, 10 April 2013. Property in Ilkley is amongst the highest value in the country. The average household income in inner city Bradford, where housing is needed, is £20,000 per annum. The cheapest property in Ilkley is around £150,000 with rents in excess of £500.00 month.

3. Balance housing with current and future employment opportunities.

COMMENT: Ilkley is a dormitory town, of outstanding natural beauty. Most working residents work either outside the town. Over 20% of residents are over 65. Because of the geographical position of **the town at** the edge of Bradford's District and the edge of the Yorkshire Dales, property is both expensive and desirable.

Promote polycentric networks of different places with complementary roles, based on their own strengths and characteristics.

COMMENT: The strength of likley and Wharfedale is it is a series of small towns and villages interspersed by special protected areas for birds and high quality farm land. Clearly attractive for large scale companies such as GVA

5. Realise the potential of Leeds City Region and ensure that benefits are spread across it.

Paragraph 52/4, No co-operation with neighbouring communities to develop new towns.

The Leeds/Bradford/West Yorkshire M62 corridor is ideal from a point of view of transport links, employment opportunities and brown field sites for housing needs.

Achieve effective environmental management and enhancement and address climate change.

Paragraph 14 and 120 The impact of building along the Wharfe Valley will significantly affect the environment. Increased traffic adding to pollution will outway the benefits specific policies indicate development should be restricted.

7. Manage development to support economic and housing growth in the District, in particular the Leeds Bradford Corridor and Airedale Corridor.

Paragraph 37. No balance of land uses - only 5Ha employment land allocated.

Paragraph 77. No sufficient school places and no land to build new school.

Paragraph 47. No mechanism too enforce affordable housing requirement in the town. Green belt land designated for development is likely to be high value accommodation outside the scope of average wage earners. Even with Help to Buy scheme.

8. Make the best use of sustainable modes of transport, including inter-city regional road and particularly rail and water transport links.

Paragragh 120 Ignores pollution affects and of waiting traffic on A65 and congestion. Rail links to Bradford and Leeds along the A65 corridor are already overcrowded at rush hour. Platforms are too short to increase the length of the train. Bus services have been cut back and because of traffic congestion take twice as long during rush hour. Costs of transport for low paid/part time workers can be beyond endurance.

9. Ensure Landscape and environmental management and enhancement.

Paragraph 28 Does not support development and diversification or agricultural and other land based rural businesses or rural tourism/leisure development.

The land north of the railway line is nationally known for ringslip problems.

Paragraphs 80, 81 and 82. Green belt should only be used in exceptional circumstances.

The above statements make it impossible for a local person to take part fully in this consultation. For this reason I feel that the plan is devised to put me at a disadvantage and therefore does not comply with ethos of involving local people.

The following statements from the NPPF have not been taken into consideration when allocating 800 houses to likely and others in Wharfedale. Unless evidence can be made available to confirm that 800 houses should to be built on green belt land in likely to meet the housing needs of local (likely) people living or working in the town, the Plan should be changed to only include necessary low cost housing. Other houses will presumably continue to be windfall properties (800 planning consents in the last 10 years. An explanation of what 'Affordable' housing is and costs should be included.

The plan should show how the calculations for each area of Wharfedale have been arrived at. Presently, spurious figures have been 'plucked' out of the air by parties who appear to have a vested interest. Building on green fields in ilkley is far more profitable than building on brown field sites in Bradford.

Ilkley should not be designated as a Principal town as it bears no resemblance to Industrial Keighley and Service center Bingley. Wharfedale is considered a tourist area of outstanding

natural beauty, attracting walkers and families to enjoy the unique spa town and protected moorland and Yorkshire Dales.
