Our capacity intake for each year group is 245 and the school is already significantly oversubscribed and in every year group. The numbers currently at the six feeder primary schools (Addingham, Ashlands, All Saints, Ben Rhydding, Burley Oaks, Burley Woodhead) are listed below:

We also take in children from the 3 private primary schools in Ilkley, as well as Askwith School. Most children at the Catholic primary school (Sacred Heart) currently go to St. Mary's; we do take some from there, and the recent proposal to remove funding for school transport for faith schools will undoubtedly increase these. In the sixth form, we are obliged to limit the number of students due to constraints on size and have a minimum 5B academic requirement for entry. This excludes a large number of students from the school who have to travel to take part in further study.

Using figures from the ONS, we estimate that 1200 new homes in our Priority 1 catchment are will contain 2,040 children under the age of 18. (1.7 per household). Assuming an even spread in age, this will be 113 for each year group. It is evident that IGS cannot accommodate the children currently in our primary system and will certainly not be able to take any new children. Our current site is physically constrained on a hillside site with off-site playing fields and cannot be developed any further.

Building School for the Future, Bradford and Ofsted all recognised the urgent need for a new IGS build – with an extra form of entry and increased Post 16 numbers. Clause 4.3.2 of your policy outlines your vision for Ilkley for 2030 and assumes a new secondary school has been built but you have not allocated any land for this in the Plan. We strongly urge you to make provision for a new site for IGS by designating all or part of site IL014 for educational use, so we can serve the Wharfe Valley.
We continue to work closely with Bradford to see this realised.
