Transport to major conurbations: I am retired now (happily!) but used to work in Little Germany, Bradford - 5 minutes work from Forster Square Station. I went into my office at about 6:15 to get in by 6:50 - invariably by car I'm afraid - not environmentally friendly nor energy efficient. I left for home at about 17:30 to 18:30. By car it took me about an hour - the traffic is awful (about 20 minutes shorter than the train) - but it was impossible either way by bus!

If I always used Public Transport see what the web site "Transport Direct Info" (see http://www.transportdirect.info/Web2/JourneyPlanning/JourneyD etails.aspx?cacheparam=3) suggests. Not very practical for a regular commute of 20 miles or less! (The walk from my house to the rail station is 15/20 minutes).

Conversely the X84 Bus Service to Leeds operates well in conjunction with the train services there.

I enquired about a journey from my house to Leeds First Direct Arena - which is 1km walk away from Leeds rail station. It takes - by car - about 45 minutes - but by train about an hour and five/ten minutes. By bus it takes one and half hours - but at least it can be done direct by bus -

unlike Bradford!

It is also probably worth noting that Leeds is currently a more desirable place to work (with better salaries and more opportunities!).

For information - I think it would cost a student living in Ilkley and needing to travel to get to Bradford for lectures in a morning and leaving at 17:00, or thereabouts, would seemingly cost £980 a year! (A 16 to 35 Rail Card does not help - for all journeys made between 4.30am and 10am Monday to Friday a minimum fare of £12 is payable. If one travels regularly before 10:00, then a weekly or monthly season ticket may be more appropriate, though one won't be able to get a Railcard discount).
