Some 1600 new houses are planned for Wharfedale, but only 5ha on new employment land.

This conflicts with the need to reduce travel detailed at 5.2.13 of the core strategy as clearly one if not two members of each household is going to require employment and the likelihood is that to obtain the salary needed to afford expensive property as in Wharfedale, that those people will need to travel to Leeds.

There may be a small growth in self-employed persons working from home, but most people are going to have to travel daily on road routes which are already over capacity or trains which are already full. Self- employed people who purchase a lease-hold flat may find themselves enforced because of restrictions on running a business from such premises.

Building houses in Wharfedale will not meet Bradford's need to house overcrowded families in Bradford and new, forming households, many of whom cannot afford even 'affordable housing' let alone have the time and funds to travel to work 10-15 miles from their new homes. Wharfedale would simply provide overspill for Leeds rather than solving Bradford's housing problem.
