The core strategy is not sound as to the number of houses for Ilkley because there is insufficient space for housing on limited brownfield sites and therefore does not comply with the Ministerial foreword that states that sustainable development must be about change for the better. It also conflicts with paras 14,47,48,52/4,158 of NPPF because it ignores the need for affordable housing especially where it is most needed which is in Bradford City and Shipley. Recent housing development in Ilkley retails at over £300,000 and most people in the Bradford District cannot afford to live and commute to work in the area.
