It claims that the Council will encourage all new housing to meet the HIGHEST POSSIBLE SUSTAINABLE DESIGN AND CONSTRUCTION STANDARDS then backs out by allowing a standard that is not the highest and allows the rider 'subject to feasibility and/or viability'. Code Level 4 is not the highest possible sustainable design and construction standard and any developer will be able to find some reason for such standards to be deemed unfeasible or unviable.
