Ilkley is a small commuter town with no large-scale employment on the edge of Ilkley Moor and as such has much on common with the Yorks Dales Nat Park and Nidderdale AONB. Along with Burley and Addingham the town benefits from tourism – because of the Wharfe Valley's historical and rural character – and because of its green belt land. Ilkley also benefits from its Literature Festival because people will come to a pleasant location. The Government's National Planning Policy Framework states green belt land is very important and should only be altered in exceptional circumstances and towns should not merge into one another and the countryside should be safeguarded to preserve the setting and character of historic towns. If the green belt were eroded this would be in direct conflict with this Policy. In the Bradford District the plan would erode 25% of green belt land but in Ilkley this would rise to 55% of green belt land which is quite simply untenable and wrong.

Sect 3 par 15.3 states sufficient infrastructure is vital. It just isn't there. The A65 is at peak capacity, there is not enough parking already, rush hour trains are overcrowded and the platforms can't be lengthened, there are no emergency medical services and local schools are already oversubscribed (and if Leeds builds more than 2000 new homes in Aireborough where can children be bussed to ?) The LIP backs this up saying there is scant provision.

Ilkley is not like Bingley or Keighley and is only a third of the size of Keighley. Both Bingley and Keighley and also Shipley have a lot more brownfield sites than Ilkley and population growth is happening in urban and greater Bradford far more than in Ilkley.

No account has been taken of the number of larger properties which have been subdivided creating at least 500 more dwellings in the last ten years (all of which has contributed to the infrastructure problems outlined above).
