No specific mention is made of the undoubted need in parts of the District, and especially in Wharfedale, for smaller and more manageable housing for pensioners who wish to downsize from their existing family sized housing.

This point, which was clearly recognised in the Menston Supplementary Guidance para 3.23, and is equally self evident in Burley, needs to be strongly emphasised.

Without such a Policy statement a significant and growing elderly population, which in Burley and Menston represents about 29% of the population, will continue to live in unsatisfactory housing and thereby limit opportunities for inwards relocation of families.

Adding such emphasis to the Policy will result in more houses coming on the market which are eminently suitable for families
