Ilkley is a small town in the larger administrative District of Bradford.

It has none of the amenities required to make it a 'Principal Town':

Services in the Town Hall have been removed to Keighley – a town larger than likley

No out of hours emergency facility - either medical or police.

No direct transport to the area hospital at Airedale

No bus service to Bradford. Train services do not cover the need adequately for visiting intermediate destinations.

Ilkley is a commuter town – indeed mainly for people working in Leeds rather than Bradford.

It is a Tourist Destination since it is attractive and on the verge of the Dales.

Apart from the Lido (unique in this area and listed) and the Riverside Park, the main attraction of great historic importance is the Grade 1 listed Manor House Museum and Art Gallery on the site of the Roman Fort. This building is currently being 'marketed' as part of the Community Asset building programme and if no viable Community Group can be formed it will be in danger of closure.

Lack of appreciation of the importance of these amenities indicates that likley is not of a scale necessary to be designated 'a Principal Town.'
