Insufficient provision for schooling – both now and the more so if development takes place.

The need to increase the capacity of Ilkley Grammar School has long been recognised by the council and also the governors of the now independent Academy. In fact an earlier earmarked site in Ben Rhydding is now designated as a potential site for new homes. If this is to be the case there is no evidence as to where a rebuilt or an additional secondary school could be sited if the prime development land is allocated for housing.

At present the 'sixth forms' of IGS are only open to students with 5 or more B grade GCSEs. There is no in valley provision for vocational training. Where are all the now required to continue to 18 in fulltime education to attend?

Students resident in Menston already attend schools in Leeds City area, as do Wharfedale students desiring a Catholic based secondary education. Since many new home sites have recently been approved for Leeds adjoining the BMDC boundary where will all the existing & additional young people be educated?

Similarly all the primary schools are full, even the most recent crisis relieved by an extension to Ashlands PS but this land allocation makes no provision for additional children from new housing.

If more students travel out of the valley this puts additional demand on crowded transport & roads and not sustainable.

Similarly if all the prime land is allocated for housing, where will the **additional** recreational provision and open space be situated? (WD 1 para B)
