The Moravian settlement of Fulneck is about 0.6 miles to the north of Tong and adjacent to green belt.

The particular way in which the Tong Ward is surrounded by Leeds territory should require City of Bradford MDC to collaborate carefully with its neighbouring local authority with its planning aspirations. In this matter, the Fulneck Moravian Church (LS28) considers this proposed urban extension environmentally harmful.

The historically significant Moravian settlement at Fulneck benefits significantly as a haven of peace and tranquility - as a direct consequence of the green belt land which surrounds it. It is felt that urban development sprawl will impair significantly – and permanently - the nature and character of the settlement, which is in a Conservation Area, and impact detrimentally on the settlement's character as an historical and cultural attraction. For this reason the Church is opposed to the Tong & Holmewood Neighbourhood Development Plan.

Fulneck Moravian Church wishes to see preserved Fulneck settlement's unique aspect, in particular the natural beauty of Tong Valley which the settlement immediately overlooks, and to try and safeguard this land from encroachment. It is so important that land afforded "Green Belt" protection and "Conservation Areas" continue to be robustly and effectively preserved from attempts to impose unwelcome and aesthetically harmful urban development.

It is historically vital that the Fulneck Moravian settlement's unique semi-rural character and outlook is preserved and secured for generations to come. The Tong and Holmewood NDP threatens this.

In addition it is hoped that the scope of any proposed building development be contained to the extent that it will not put undue pressure on existing local roads, or be such that additional roads are considered necessary to deal with increased traffic; our aspirations are to see development and environmental change limited and without derogation to the natural beauty of Tong Valley overlooked by Fulneck settlement.
