I consider the core strategy to be unsound, with regard to proposed development in likely and surrounding areas, as it conflict with National Planning Policy on preserving the green belt and farmland it encloses.

I believe the core strategy conflict with NPPF with regards to paragraphs 80,81 & 82. Green belts should only be altered in exceptional circumstances.

I also consider the plan to be unsound, with regard to proposed development in Ilkley and surrounding areas, as there no plan in place to deal with the consequences of the proposed number of new dwellings. I can see no plans to improve the current supporting infrastructure, with regards, road transport, rail transport, schools, & healthcare.

I believe the core strategy conflict with NPPF with regards to: paragraphs 77. No sufficient choice of school places; paragraphs 29-32. Promoting sustainable transport; Paragraphs 120 minimum regard for pollution effects.

I also feel that the core strategy plan has failed in its duty to co-operate. I believe the documentation, forms, time constraints, lack of plain English, and lack of availability of the document in other languages, have been constructed to minimise representation of the local people.
