No attempt was made by Bradford Council to reshape the Tong and Holme Wood Partnership Board so that it met the requirements of the Localism Bill in devising an NDP. The Draft Core Strategy refers frequently to the Tong and Holme Wood NDP in a way that assumes validity for it that should not be claimed.
