The whole urban extension is proposed to be built on Greenbelt land, I thought the National Policy was to protect this land and had very specific guidelines so situations like this would not arise.

- 1. To prevent the merging of Leeds and Bradford into one large urban sprawl, which it would clearly do.
- 2. To preserve the historic village of Tong and also local woodlands within the valley which contain ancient Oak trees
- 3. To protect the local leisure / outdoor activities which take place all day, every day in the surrounding valley. This area is used extensively by Horse-riders, Walkers, Cyclists, Runners and Dog walkers like myself to whom this would greatly affect.
- 4. Local businesses would suffer, we have a pub in the village which is visited because it has a lovely country feel to it, Tong will just become another suburb of Bradford/Leeds and lose all of it's appeal.
- 5. Also the increased traffic in the village and surrounding area, which is horrific already will certainly increase and with a young family is extremely worrying.
