The visual, social and recreational amenity which will be lost to both local residents and visitors alike has been absent from investigations and comment within the proposals.

Degrading of the Green Belt zone dividing Leeds and Bradford has seriously negative effects and constitutes precedent for future infringements.

I am a regular user of the Green Belt affected in this Planning proposal. I have serious concerns that issues related to increased traffic generated by the proposed development will affect the recreational activities of horse riders and other organisations using this area for social and recreational pursuits. The roads are narrow and unsuitable to handle increased traffic movements.

As someone who uses the area affected by this proposal I along with many friends am wholly against the proposals to develop.

Environmental impact including natural habitat and rivers does not appear to have been investigated in any depth.
