I write to express my concern at the proposed use of green belt land for building.

The visual aspect of the Coutances Way development would spoil the approach to the Town and new access roads would add to the problems of an already overloaded A65. Has consideration been given to the effect on Schools, Doctors and other essential services if many more houses are built in the area?

The same arguments apply to the Ben Rhydding Drive proposal and the added congestion it would cause at the junction of Wheatley Lane and Bolling road and the one-way priority at the railway bridge would be unacceptable.

I hope that the greed of the large house builders will not persuade the Council to sacrifice our open countryside for short term profit.
