

## Proposed Amendments to Main Modifications –May 2016

Proposed amendments to the Council's Main Modifications (November 2015 - PS/G004a) that arose during the Core Strategy examination hearings in May 2016 and revised evidence base are set out in the table below.

In terms of presentation of the Main Modifications proposed by the Council in November 2015, the deletion of text is denoted with a 'strike through' (~~strike through~~), with inserted new text as bold underlined (**new text**). This convention has also been followed for the proposed amendments, but with additional new text identified as bold, underlined and in italics.

Where necessary for the protection of the South Pennines Moors SPA, mitigate (which may include avoidance) loss or deterioration of important foraging land within the SPA's zone of influence.</u></b></p>
