Baildon town council is minded to make the following comments on the core strategy and its modifications.

We welcome the reduction in housing allocation for Baildon but feel that more note needs to be taken of the effect development in a large part of Baildon could have on the Saltaire Heritage Site. The Council supports the concept that a much slower pace and scale of growth, compared to urban areas, forms the overall approach in the Local Service centres. We would, though like to see a much more intense commitment to improving the local infrastructure, including the road accesses to these centres, so that they keep pace with the needs of the area.

We are particularly concerned that Lower Baildon, as part of the extended Regional City of Bradford and

additional to the Baildon Local service Centre may include further development allocations.

In particular, the recent floods and the consequent flooding of houses recently built at Berry Drive, call into question the viability of any housing developments within Lower Baildon. Additionally, the damage to businesses in Lower Baildon means that any commercial and industrial developments need to have their future resilience as top priority.
