This 'exceptional circumstance' to Green Belt is not justified. The Council has set an overall target that is only a forecast of what may be needed over the next fifteen years. Bradford Council cannot guarantee future economic and political conditions that are outside of its control. To set an arbitrary target in this rigid manner, as it has done in the past, is to fail. It also creates a 'rod for its own back' and fears among many small communities, such as Burley.

The pressure to allocate land in the Greenbelt, beyond what an area can reasonably stand, is to lead to a charge of a flawed and unbalanced process. In specific terms, Burley has been heavily penalised by increasing the original allocation for 200 to 700 dwellings. In this instance, the impact of this scale of development, leading to a 27% increase in population, is not justified when set against NPPF guidelines on Green Belt. There are no 'exceptional circumstances' which justify in Burley coping with an increase

on this scale. Coalescence of settlements and impact on the landscape character of Whafedale are important factors that have not been taking into sufficient consideration, along with infrastructure deficiencies. Bradford Council's proposals are ill-judged and unworkable in the longer-term.

No land release should take place in Burley until proper improvement are made to the road and public transport capacities otherwise there will be a constant logiam of delays with their economic consequences.
