collaboratively with other waste planning authorities to provide a suitable network of facilities to deliver					
sustainable waste management to allow Bradford District to become net self-sufficient.					

It is noted however that the revised policy recognises that cross-boundary movements will continue, and seeks a collaborative approach with other waste planning authorities to provide a "network of facilities to deliver waste management" There are some concerns with this approach and perhaps further clarity is needed on how this would be achieved. It is difficult to see how Bradford waste could be planned for and managed in a wider planning context, whether on a County basis or further afield, without direct

collaboration with other authorities to provide a joint waste facility.
