Burley employment land requirement in the current Core Strategy was part of the 5ha in the Wharfedale corridor and was linked to housing need of 200 new homes over the next 15 years. In the modifications there is still a requirement for 5ha in the Wharfedale corridor but the housing requirement in Burley as an example has gone up from 200 to 700 new homes. If the employment had increased via Policy EC3 one could understand the increased housing need but the same employment land cannot suddenly require an additional 500 new homes.
