## LOCAL DEVELOPMENT FRAMEWORK FOR THE BRADFORD DISTRICT

The City of Bradford Metropolitan District Council proposes to adopt its Supplementary Planning Documents (SPD).

The proposed Supplementary Planning Document for *Bradford City Centre Affordable Housing* sets out the approach that will be taken by the Council with regard to the implementation of its affordable housing policy in Bradford City Centre. The Council adopted this document on 1<sup>st</sup> October 2008.

The proposed Supplementary Planning Document for *City Centre Design Guide* provides urban design guidance for the Bradford City Centre Regeneration Area. The Council adopted this document on 21<sup>st</sup> March 2006

The proposed Supplementary Planning Document for *Landscape Character* provides guidance on the Council's approach to landscape conservation, enhancement and management, and applies District wide. The Council adopted this document on 1<sup>st</sup> October 2008.

The proposed Supplementary Planning Document for *Planning for Crime Prevention* provides guidance on how development can be designed in a manner which promotes safer and more secure places. The Council adopted this document on 26<sup>th</sup> June 2007.

The proposed *Shopfront Design Guide* Supplementary Planning Document sets the expected standards for the design of shopfronts and signage to commercial premises across the District. The Council adopted this document on 19<sup>th</sup> December 2007.

The proposed *Sustainable Design Guide* Supplementary Planning Document informs all participants in the development control process about the principles of sustainable design and how these can be incorporated in new development, conversion and refurbishment. The Council adopted this document on 28<sup>th</sup> February 2006.

Any person aggrieved by the proposed adoption of any of the SPDs may apply to the High Court for permission to apply for judicial review of the decision to adopt the SPD(s). Any such application for permission must be made promptly and in any event not later than three months after the date on which the SPD(s) was adopted.
