### Review of Council Tax Carer Disregard Discount

## **Disabled Band Reduction**

You may be able to get an extra reduction on your Council Tax bill if a person living in your home has one of the following because of their disability:

- a wheelchair they use indoors or
- an extra bathroom or
- an extra kitchen or
- a room to meet their needs e.g. physiotherapy room, dialysis room

### **But NOT**

- an extra lavatory
- a stairlift
- handrails

The Band Reduction can be granted as well as your Council Tax discount but it can only be granted once even if you have more than one qualifying feature.

The Band Reduction can be for an adult or a child and is not dependent upon the person with disabilities being registered disabled or being in receipt of a particular benefit, but they must have a permanent disability.
