## The Acquisition of Land Act 1981

The City of Bradford Metropolitan District Council (in this order called "the acquiring authority") makes the following order: -

- Subject to the provisions of this order, the acquiring authority is under section 47 of The Planning (Listed Buildings and Conservation Areas) Act 1990 and under section 2 of the Acquisition of Land Act 1981 hereby authorised to purchase compulsorily for the purpose of (a) preserving a Grade 11 Listed Building situate and known as No 23 Rosebery Road, Manningham, Bradford BD8 7QB and (b) an area of garden land abutting the said Listed Building lying to the north east of the Listed Building and situate at the junction of Oak Lane and Rosebery Road, Manningham, Bradford, which is needed to be purchased to facilitate the preservation of the Listed Building and to afford access to the Listed Building for its proper control and management.
- 2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown coloured pink on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in The City of Bradford Metropolitan District Council (The Old Manor House, Rosebery Road, Manningham, Bradford) (Listed Building Renovation Scheme) Compulsory Purchase Order 2022.
- 3. Parts II and III of Schedule 2 to the Acquisition of Land Act 1981 are incorporated with this order subject to the modifications that
  - (a) references in those Parts to the undertaking shall be construed as references to the land authorised to be purchased and to any buildings or works constructed or to be constructed on it; and
  - (b) the prescribed distance in relation to any seam of minerals lying under land adjoining the works to be constructed upon the land described in the Schedule to this order, shall be such a lateral distance from every side of those works, as is equal at every point along those works to one half of the depth of the seam below the natural surface of the ground at that point, or forty yards, whichever is the greater.
