Staff update

Mobile Phone Convictions

The Service has noticed a sharp increase in CU80 Mobile Phone offences and want to reiterate the importance of making drivers aware that such a conviction can mean a revocation of their licence.

Online Modular Training

The Service is currently working with external parties to produce and implement an online training platform for various training programmes such as, Modular Training, Operator Training, Driver Training etc. The Service has listened to previous feedback given regarding the difficulties of new and renewal drivers having to book time out of

work to travel to an in-person training programme, issues with driving to the Depot and having issues parking. An online platform will alleviate the above as drivers will be able to book and complete training from their home and at a time suitable to them. This is in the initial stages, and we will consult further when more information is available.

DfT Mandatory Guidance

The Service has received the updated November 2023 Dft Mandatory Guidance and are working to ensure that the Service, the trade, Operators and Hire Companies are in line with the required standards from the DfT. There will be future meetings held for you to be able to have an input and to be supported with any changes that may affect the running of your business.

Dual Operator Working

The Service has taken on board the comments previously noted regarding drivers being able to work for more than one operator. It was made aware that Operators are not always aware that a driver will be working with themselves and another Operator. To help support these issues the Service has updated the Northern Data Hub to include which Operator each driver is working with.
